The Ranked List is brought into force with effect from 07.07.2016.

The Ranked List shall remain in force for a minimum period of one year provided that the said list will continue to be in force till the publication of a new Ranked List after the expiry of a minimum period of one year or till the expiry of three years whichever is earlier. Candidates from this list will be advised for appointment in accordance with the rules and orders regarding reservation and rotation as amended from time to time, if applicable against vacancies reported to the Commission during the pendency of the list. Applications submitted in any other manner will not be considered. The valid applications for rechecking of answer script along with the original chalan receipt for prescribed fee addressed to the District Officer, Kerala Public Service Commission District Office, Idukki, Kattappana P.O., shall reach this office within 45 days from the date on which the ranked list has come into force (i.e. the date on which the ranked list has been approved by the Commission).

Candidates who wish to obtain a photocopy of their OMR Answer sheet (Part A & Part B) relating to this selection shall remit a fee of **Rs. 300/-**(Rupees Three Hundred only) by way of challan in any of the treasuries in the State (Head of Account **0051 PSC -800 State PSC -99 other receipts**). The duly filled up application in the prescribed form (available from the commission's website) along with the original challan should be submitted to the District Officer, K.P.S.C District Office, Kattappana P.O, Idukki within 45 days from the date on which the Ranked List is brought into force. **A copy of the answer sheet will be issued only once to a candidate.** Copies of OMR Sheet invalidated due to any defect will not be issued. Candidates are prohibited from applying for copy of answer sheet which is not their own, and legal proceeding will be initiated against those who do so.
