Candidates who wish to obtain a photocopy of their OMR Answer sheet (Part A & Part B) relating to this selection shall remit a fee of **Rs. 300/-**(Rupees Three Hundred only) by way of challan in any of the treasuries in the State (Head of Account **0051 PSC -800 State PSC -99 other receipts**). The duly filled up application in the prescribed form (available from the commission's website) along with the original challan should be submitted to the District Officer, K.P.S.C District Office, Kattappana P.O, Idukki within 45 days from the date on which the Ranked List is brought into force. **A copy of the answer sheet will be issued only once to a candidate.** Candidates are prohibited from applying for copy of answer sheet which is not their own, and legal proceeding will be initiated against those who do so.

"Any candidates can relinquish his/her right for appointment in writing duly attested by a Gazetted Officer of State/Central Government with signature, name, designation and Office seal. The request for relinquishment received within 15 days from the date of publication of Ranked List will be honoured against the requisitions of vacancies that are pending with the Commission up to the finalisation of Ranked List. After the publication of the Ranked List, the request for relinquishment will be considered only if such request is received on or before the date of receipt of requisition, based on which he/she is to be advised"
