#### **NOTIFICATION**

The following list contains the names of candidates found suitable on the basis of the result of Objective Type (OMR valuation) Test held on 06.08.2014 and the verification of original documents of candidates included in the Probability List published on 24.06.2016 for selection to the post of **Lower Division Clerk (SR for Differently Abled) on ₹ 9940-16580** in Various **Departments in Ernakulam District** (Cat.No.258/12) notified in the gazette dated 30.04.2012 arranged in the order of merit.

The Ranked List is brought into force with effect from 05.09.2016. The Ranked List is intended to make recruitment to the 3% backlog vacancies of Differently Abled candidates during the period from 01/01/2004 to 31/12/2007 as earmarked for the various categories and DA groups as per G O (P)No.7/2011/SWD dated 24/01/2011 and will remain in force for maximum period of three years subject to the condition that the Ranked List will cease to exist as and when candidates are advised and appointed against the above mentioned backlog vacancies. Rules 14 to 17 of Part II, KS &SSR are not applicable to this selection.

Candidates will be advised and appointed aganist the vacancies notified and also against the backlog vacancies, if any, reported by the appointing authorities as earmarked in G.O.(P) No. 7/2011/SWD dated 24/01/2011.

The candidates who have obtained 30.13 {Thirty (point) one three} marks or above (Marks secured in the OMR Test + Grace marks for DA candidates) have been included in the Low Vision category of this Ranked List.

The candidates who have obtained 26.27 {Twenty Six (point) two seven}marks or above (Marks secured in the OMR Test + Grace marks for DA candidates) have ben included in the Hearing Impairment category of this Ranked List.

The candidates who have obtained 54.61{Fifty Four (point ) Six One} marks or above (Marks secured in the OMR Test + Grace marks for DA candidates) have ben included in the Locomotor Disability/ Cerebral Palsy ( Upper extremities (Minor) Lower extremities) category of this Ranked List.

According to the existing procedure, re-valuation of answer scripts is not allowed. But answer scripts will be rechecked to see that all the answers are valued and that there is no mistake in the totalling of marks for various answers, if the candidates apply for rechecking by remitting the prescribed fee of Rs.75/- (Rupees Seventy Five only) in any one of the Treasuries in the State under the Head of Account "0051 PSC 105 State PSC 99 Examination Fee". Candidates who wish to obtain a photocopy of their OMR answer sheet (Part A& B) relating to this selection shall remit a fee of Rs.300/- (Rupees Three Hundred only) by way of chalan in any of the Treasuries in the State under the Head of Acount 0051 -PSC-800-State PSC- 99 Other receipts. The duly filled up application in the prescribed form (available from the Commission's Website www.keralapsc.gov.in ) along with the original chalan should be submitted to the District

Officer, KPSC District Office, Ernakulam within 45 days from the date on which the Ranked List has come into force. A copy of the answer sheet will be issued only once to a candidate. Copies of OMR Sheet invalidated due to any defect will not be issued. Candidates are prohibited from applying for a copy of answer sheet which is not their own, and legal proceedings will be initiated against those who do so.

Applications for rechecking/ obtaining photocopy of answer scripts should be submitted in the prescribed form available free of cost from the enquiry sections of the various offices of the Commission or its photocopy or downloaded and printed in A4 size paper from the Commission's website <a href="www.keralapsc.gov.in">www.keralapsc.gov.in</a> or photocopied there from. Applications submitted in any other manner will not be considered.

Valid applications for Re-checking /obtaining photocopy of Answer Scripts along with original chalan receipt addressed to the District Officer, Kerala Public Service Commission, District Office, Ernakulam shall reach this office within **45 days** from the date on which the Ranked List has come into force (ie. The date on which the Ranked List has been approved by the Commission). The last date for receipt of application for rechecking/obtaining photocopy of the Answer Script is **20.10.2016**. Applications for rechecking/obtaining photocopy received after the prescribed time limit or not in the prescribed form will not be entertained. The fee once remitted will not be refunded on any account. In the case of candidates who sent applications for rechecking in the prescribed form within the prescribed time limit enclosing original chalan receipt as stated above, the marks awarded will be rechecked and the result of the rechecking will be intimated to the candidates from this office.

"Any candidate can relinquish his/her right for appointment in writing duly attested by a Gazetted Officer of State/Central Government with signature, name, designation and Office Seal. The request for relinquishment received within 15 days from the date of publication of Ranked List will be honoured against the requisitions of vacancies that are pending with the Commission up to the finalisation of Ranked List. After the publication of the Ranked List, the request for relinquishment will be considered only if such request is received on or before the date of receipt of requisition, based on which he/she is to be advised".
