The application of the candidates in the List who fail to produce the required Non-Creamy Layer Certificate will be rejected without further notice.
 6. Copy of answer scripts of the OMR Test held on **19/10/2016** will be issued to those candidates who, apply for the same remitting the prescribed fee after publication of the Ranked List.
