 4. According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be incorporated in the Ranked List to be published for the post.
 5. Candidates included in the list shall produce Community Certificate obtained from Revenue Authorities not below the Rank of Tahsildar. The register numbers of the candidates will be deleted from the short list without further notice, if they fail to produce Community Certificate along with other relevant documents at the time of verification of original documents.
 6. Copy of answer scripts of the OMR Test held on **15/10/2016** will be issued to those candidates who, apply for the same remitting the prescribed fee after the publication of the Ranked List. Candidates whose Register Numbers are invalidated are advised to refer to Invalidation Notification No : **ER II(2)2163/16/EW-16 DATED 30/08/2017**.
