- (iv) In case of change in caste noted in the SSLC book,candidate must claim their original caste in the application and shall produce caste certificate /Non Creamy Layer Certificate issued by the Revenue authorities and the Gazette notification publishing the change of caste at the time of OTR verification for selection to the above post.
- (v) The selection in pursuance of this notification will be made on a Revenue District basis, subject to the special conditions laid down in G O (MS) No. 154/71/PD dated 27.05.1971.
