**NOTIFICATION**

The following list contains the names of candidates found suitable on the basis of the result of the objective (OMR) type test held on 26.03.2014 (Category No. 179/2012), for selection to the post of **Lower Division Typist (NCA-LC)** on Rs. 9940-16580 in the **Various Departments** in Idukki District found suitable by the commission and arranged in the order of merit. The Ranked List is published on the basis of the Gazette Notification dated 30.04.2012 (Category No.179/2012). The Ranked List is brought into force w.e.f **08.03.2016**.

The Ranked List will remain in force until candidates are advised and appointed against the NCA vacancies notified due to the paucity of candidates belonging to Latin Catholic Community during the currency of Ranked List published for the post on 05.12.2007 in Idukki District ( Category No.225/2005).As the advice for appointment depends on the occurrence of vacancies, there is no guarantee that all the candidates included in the list will secure appointment. The candidates remaining in the list at the time of cancellation will have no claim at all for appointment on the basis of the inclusion of their names in the list.

According to the existing procedure, re-valuation of Answer Script is not allowed. But re-checking of marks will be done on payment of Rs.75/- (Rupees Seventy Five only) in any one of the Treasuries in the State under the Head of Account "**0051 PSC,105 State PSC, 99 Examination Fee**". The fee once remitted will not be refunded on any account. The result of the rechecking will be intimated to the candidate from this office. Application for rechecking of answer script should be submitted in the prescribed form available free of cost from the Enquiry Section of the various offices of the Commission or its photocopy or downloaded and printed in A4 size paper from Commission's **Website [www.keralapsc.gov.in](http://www.keralapsc.gov.in)** or photocopied therefrom. Applications submitted in any other manner will not be considered. The valid applications for rechecking of answer script along with the original chalan receipt for prescribed fee addressed to the District Officer, Kerala Public Service Commission District Office, Idukki, Kattappana P.O., shall reach this office within 45 days from the date on which the ranked list has come into force (i.e. the date on which the ranked list has been approved by the Commission).

Candidates who wish to obtain a photocopy of their OMR Answer sheet (Part A & Part B ) relating to this selection shall remit a fee of Rs. 300/-(Rupees Three Hundred only) by way of challan in any of the treasuries in the State (Head of Account **0051 PSC -800 State PSC -99 other receipts**). The duly filled up application in the prescribed form (available from the commission's website) along with the original challan should be submitted to the District Officer, K.P.S.C District Office, Kattappana P.O, Idukki within 45 days from the date on which the Ranked List is brought into force. A copy of the answer sheet will be issued only once to a candidate.

Copies of OMR Sheet invalidated due to any defect will not be issued. Candidates are prohibited from applying for copy of answer sheet which is not their own, and legal proceeding will be initiated against those who do so. Valid applications for rechecking/photocopy of answer script addressed to **District Officer, K.P.S.C District Office, Kattappana P.O, Idukki** shall reach this office within 45 days from the date on which the ranked List is brought into force. The Last date for receipt of applications for rechecking/Photocopy of answer script is **21.04.2016**. Applications for rechecking/photocopy received after the prescribed time limit and not in the prescribed form will not be entertained.

Any candidates can relinquish his/her right for appointment in writing duly attested by a Gazetted Officer of State/Central Government with signature, name, designation and Office seal. The request for relinquishment received within 15 days from the date of publication of Ranked List will be honored against the requisitions of vacancies that are pending with the Commission upto the finalisation of Ranked List. After the publication of the Ranked List, the request for relinquishment will be considered only if such request is received on or before the date of receipt of requisition, based on which he/she is to be advised.
