A copy of the answer sheet will be issued only once to a candidate. Candidates are prohibited from applying for copy of answer sheet which is not their own and legal proceedings will be initiated against those who do so.

Valid applications along with the original chalan, for re-checking/obtaining photocopy of answer script addressed to the **District Officer**, **Kerala Public Service Commission District Office**, **Kottayam** shall reach this office within 45 days from the date on which the Ranked List has come into force (i.e. the date on which the Ranked List has been approved by the Commission). After the publication of the Ranked List, the request for relinquishment will be considered only if such request is received on or before the date of receipt of requisition, based on which he/she is to be advised.
