Note :- (5) Candidates belonging to Other Backward Classes included in this list who are required to produce Non - Creamy Layer Certificate as per G.O (P) No: 81/09/SC/ST/DD dated 26.09.2009 shall produce the same along with the other documents mentioned above at the time of verification of original documents. SC/ST candidates included in the short list are required to produce Community Certificate issued under rule 4 of Kerala(scheduled caste and Scheduled Tribes) Regulation of issue of Community Certificate rules,2002 by the Revenue Authority.

Note :- (6) Copy of answer scripts of the OMR Test held on **21/04/2016** will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List.
