Note :- (5) Candidates belonging to Other Backward Classes included in this list who are required to produce Non - Creamy Layer Certificate as per G.O (P) No: 81/09/SC/ST/DD dated 26.09.2009 shall produce the same along with the other documents mentioned above at the time of verification of original documents. SC/ST candidates included in the Probability list are required to produce Community certificate issued under rule 4 of Kerala (Scheduled caste and Scheduled tribes) Regulation of issue of Community Certificate rules, 2002 by the Revenue Authority.
