The duly filled up application in the prescribed form (**available from the commission's website [www.keralapsc.gov.in](http://www.keralapsc.gov.in)**) along with the original challan should be submitted to The **District Officer, K.P.S.C District Office, Ernakulam** within 45 days from the date of this Notification. A copy of the answer sheet will be issued only once to a candidate. Copies of OMR answer sheets invalidated due to any defect will not be issued. Candidates are prohibited from applying for a copy of an answer sheet which is not their own, and legal proceedings will be initiated against those who do so. The last date for receipt of applications is 10.09.2016. Applications received after the prescribed date will not be entertained.

A period of 45 days time to apply for re-checking of answer scripts will be allowed to candidates with effect from the date of this Notification. The candidates can avail only one chance.

“Applications for re-checking of answer scripts should be submitted in the prescribed form available free of cost from the Enquiry Sections of the various offices of the Commission or its photocopy, or downloaded and printed in A4 size paper from the Commission's website [www.keralapsc.gov.in](http://www.keralapsc.gov.in) or photocopied there from.
