NOTE : I

Since a common OMR test with common candidates was conducted for this post, the marks awarded to the candidates included in this Ranked List and mark of OMR test relating to all candidates appeared for the test will be published only after the publication of entire Ranked Lists (including NCA Notifications) which will be finalized on the basis of the common test.

NOTE : II

The result of rechecking of OMR answer scripts will be intimated in due course. But photo copy of the OMR answer scripts will be issued only after the publication of the Ranked Lists for all the posts finalized on the basis of the common test.

NOTE : III

Candidates who wish to obtain a photocopy of their OMR answer sheet (Part A & part B) relating to this selection shall remit a fee of Rs.300/- (Rupees Three Hundred Only) by way of chalan in any of the treasuries in the State under the Head of Account 0051 PSC-800 State PSC – 99 other receipts. The duly filled up application in the prescribed form (available from the Commission's website) along with the original chalan should be submitted to the District Officer, K.P.S.C District Office, Alappuzha within 45 days from the date on which the Ranked List is brought into force. A Copy of the answer sheet will be issued only once to a candidate. Candidates are prohibited from applying for

copy of answer sheet which is not their own, and legal proceedings will be initiated against those who do so. The last date for receipt of applications is 02.03.2017. The applications received after the prescribed date will not be entertained.

NOTE : IV

A period of 45 days time to apply for rechecking of Answer Scripts will be allowed to candidates with effect from the date on which this Ranked List is brought into force. The candidates can avail only one chance.

“Application for rechecking of answer scripts should be submitted in the prescribed form available free of cost from the Enquiry sections of the various offices of the Commission or its photocopy, or downloaded and printed in A4 size paper from the Commission’s website www.keralapsc.gov.in or photocopied there from. Applications submitted in any other manner will not be considered”.

The application for rechecking, along with original chalan receipt for the prescribed fee of Rs.75/- under the head of account “0051 – PSC 105 State 99 – Examination Fee”, addressed to the The District Officer, Kerala Public Service Commission District Office, Alappuzha should reach the office on or before 02.03.2017. Application rechecking received after the stipulated time will not be entertained and fee once remitted will not be refunded.

NOTE : V

“Any candidate can relinquish his/her right for appointment in writing duly attested by a Gazetted Officer of State/Central Government with signature, name, designation and office seal. The request for relinquishment received within 15 days from the date of publication of Ranked List will be honoured against the requisition of vacancies that are pending with the Commission up to the finalisation of Ranked List. After the publication of the Ranked List, the request for relinquishment will be considered only if such request is received on or before the date of receipt of requisition, based on which he/she is to be advised”.
