Applications submitted in any other manner will not be considered.

In the case of candidates who send applications for rechecking in the prescribed form within the prescribed time limit enclosing original chalan receipt as stated above, the marks awarded will be rechecked and the result of the rechecking will be intimated to the candidates from this office.

Candidates who wish to obtain a photocopy of their OMR answer sheet (Part A and B) relating to this selection shall remit a fee of ₹.300/- (Rupees Three hundred only) by way of chalan in any of the Treasuries in the State (head of account, "0051-PSC-800 State PSC-99 other receipts"). The duly filled up application in the prescribed form (available from the Commission's website) along with the original chalan should be submitted to the **DEPUTY SECRETARY (EXAMINATIONS)-II, KERALA PUBLIC SERVICE** COMMISSION, PATTOM, **THIRUVANANTHAPURAM** within 45 days from the date on which the Ranked List has come into force. A copy of the answer sheet will be issued only once to a candidate. Candidates are prohibited from applying for a copy of answer sheet which is not their own, and legal proceedings will be initiated against those who do so.
