But Answer Scripts will be rechecked if the candidates apply for in the prescribed application form available free of cost from the Enquiry Sections of the various Officers of the Commission or its photocopy, or downloaded and printed in A4 size paper from the Commission's website www.keralapsc.gov.in or Photocopied there from along with prescribed fee of Rs. 75/- (Rupees Seventy Five Only) under the Head of Account "0051 - PSC - 105 State PSC 99 - Examination Fee" addressed to the Deputy Scretary (Examinations)-I, Kerala Public Service Commission, Pattom P.O., Thiruvananthapuram. - 4.

Applications submitted in any other manner will not be considered. A period of 45 (Forty Five) days time to apply for rechecking of Answer Scripts will be allowed to candidates with effect from the Date of Approval of the Ranked List (on or before **29.07.2016**). The candidates can avail only one chance after the Approval of Ranked List.
