6.Age limit:18-36, only candidates born between **02/01/1982** and **01/01/2000** are eligible to apply for this post

I) A Bachelor's Degree in Physiotherapy

OR

II)a)Pass in Pre-University Examination or Pre-Degree Examination or its equivalentb)Diploma in Physiotherapy from an institution recognized by State Government

c) Training given to Physiotherapist Assistant Class II of Armed Forces

Note I: Preference will be given to those with Bachelor's Degree in Physiotherapy.

<u>Note II</u>:Candidates who claim equivalent qualifications instead of qualification mentioned in the Notification shall produce the relevant Government Order to prove the equivalency at the time of verification, then only such qualifications shall be treated as equivalent to the prescribed qualification.

<u>Note III</u>:In the case of difference in original Caste / Community claimed in the application and that entered in S.S.L.C book, the candidate shall produce a Gazette Notification in this regard, along with Non Creamy Layer Certificate / Community Certificate at the time of Certificate Verification.

Name of the candidate and the date of photograph taken should be printed legibly at the bottom portion. The photograph once uploaded meeting all requirements shall be valid for 10

years from the date of uploading. There is no change in other instructions regarding the uploading of photographs. No application fee is required. Candidates shall take a printout of the application by clicking the link Registration Card in their profile. Candidates are responsible for the correctness of the personal information and secrecy of password. Before the final submission of the application on the profile candidates must ensure correctness of the information in their profile. They must quote the User ID for further communication with the Commission. Application submitted is provisional and cannot be deleted or altered after submission. The application will be summarily rejected if noncompliance with the notification is found in due course of processing. Documents to prove qualification, age, Community etc. have to be produced as and when called for
