Applications are invited online only by One Time Registration exclusively from qualified candidates for selection to the undermentioned post (By transfer recruitment).

- 1. Department : Education
- 2. Name of post : High School Assistant (Sanskrit) (By Transfer)
- 3. Scale of pay : Rs. 29200-62400 (Revised)
- 4. Number of vacancies : District wise

- Note: (i) Conventional type applications will be summarily rejected. Candidates can apply online only by One Time Registration to <u>www.keralapsc.gov.in.</u>
 - (ii) In the absence of suitable candidates, the vacancies set apart for By Transfer recruitment shall be filled up by the candidates from the Ranked List prepared for Direct recruitment.
 - (iii) The applicant should be an approved probationer/Full member of the Kerala General Education subordinate service, as on the date of application.
 - (iv) A Ranked List will be prepared for Kasaragod district in pursuance of this notification. The Ranked lists thus prepared and published by the Commission, shall remain in force for a minimum period of one year, subject to the condition that the said list will continue to be in force till the publication of a new list after the expiry of the minimum period of one year or till the expiry of three years whichever is earlier. Candidates will be advised for appointment against the vacancies reported during the currency of the lists. In case no candidate is advised from the ranked list till the expiry of the period of three years, the duration of the ranked list shall be extended for a further period of one year or till at least one candidate is advised from the list whichever is earlier.
 - (v) Candidates should apply to Kasaragod District in response to this notification where the vacancy is existing and note the name of the district against the relevant column of the application.
 - (vi) The selection in pursuance of this notification will be made on a revenue district basis, subject to the special conditions laid down in G.O. (Ms)No.154/71/PD dated, 27.05.1971. A candidate advised for appointment in one revenue district from the Ranked List prepared is not eligible for transfer to another district unless he/she completes five years continuous service from the date of commencement of service in the former district. Even if transfer is allowed after five years, it will be subject to the rules in G.O(MS)No.4/61/PD, dated 02.1.1961. But as per the GO(P) No 12/96/P&ARD dated 16.3.1996 the condition of 5 years service is not applicable for transfer to Idukki, Wayanad and Kasaragod districts. The concession will be available only for getting transfer to these districts but not for getting transfer out of these districts. And this concession will be granted only once in the career of a Govt Servant. Candidates already in Government service holding this post in any one district are prohibited from applying again for this post, but they can apply to higher posts when notified.
 - (vii) The rules regarding the reservation of appointment contemplated in Article 14 to 17 in Part II of the KS & SSR are not applicable to recruitment by transfer.

 - (A) A Degree in Sanskrit and B.Ed/BT/LT conferred or recognized by the Universities in Kerala

OR

Title of Oriental Learning in Sanskrit awarded or recognized by the Universities in Kerala and Certificate in Language Teachers Training issued by the Commissioner for Government Examinations, Kerala. [In regard to High School Assistant (Languages) in Government Schools, a title of Oriental Learning in the concerned language awarded or recognized by the Universities in Kerala shall also be accepted in lieu of Degree if these titles have been declared as equivalent to part III of the Degree].

- 'Siksha Sastri' Examination of the Rashtriya Sanskrit Sansthan and 'Siksha Sastri' <u>Note:-(i)</u> Examination of the Kameswar Singh Darbhanga University of Bihar will be treated as equivalent to B.Ed Degree examination of the Universities in Kerala for the purpose of appointments as High School Assistant Sanskrit.
 - (ii) Post Graduates in Sanskrit are also eligible to apply provided that they have B.Ed/B.T/L.T
 - *(iii) B.Ed should be in the concerned Language.*
- **(B)** Must have passed the Kerala Teacher Eligibility Test (K-TET) for this post conducted by the Government of Kerala. Exemption: Candidates who have qualified CTET/NET/SET/M.Phil/Ph.D/M.Ed. in the respective subjects are exempted from acquiring TET (G.O. (P) No. 145/16/G.Edn. Dated 30.08.16 and G.O. (P) No. 206/16/G.Edn. Dated 08.12.2016).
- i) M.Phil in the concerned subject be the one awarded by any of the Universities in Kerala or Note:recognised as equivalent by any of the Universities in Kerala.
 - ii) The Employees of the General Education Department who have completed the prescribed service and who are working as Clerk/Typist/Attender/Office Attendant can apply to the above post even if they have not passed the Kerala Teacher Eligibility Test (K-TET) subject to the condition that they should acquire the K-TET qualification within 31.03.2019 (G.O. (MS) No. 134/2017/G.Edn. Dated 30.10.2017)

The Employees of the General Education Department who have entered in service before 31.03.12 and have *completed the* prescribed period of service *Clerk/Typist/Attender/Office Attendant are exempted from acquiring KTET qualification.*

- Service as Clerk/Typist/Attender/Office Attendant in the General Education Department with not less than 5 years as on the date of application.
 - Note: 1) Rule 10 a(ii) of Part II of KS &SSR is applicable for this post.
 - 2) Candidates claiming equivalent qualification should produce relevant Government orders during verification to prove that the qualification claimed is equivalent to the prescribed qualification for the post.
