Applications are invited online only by **One Time Registration** system exclusively from qualified candidates for selection to the under mentioned post. Applications must be submitted online through the official website of the Kerala Public Service Commission after One Time Registration. Candidates who have already registered shall apply through their profile.

1. Department : Public Works (Electrical Wing)
2. Name of post : Lineman
3. Scale of pay : Rs. 19000-43600/-
4. Number of vacancies : **District wise**
Alappuzha ±01 (One)

Notes:

- (i) A Ranked Lists will be prepared for the above District in pursuance of this notification. The Ranked list thus prepared and published by the Commission, shall remain in force for a minimum period of one year, subject to the condition that the said list will continue to be in force till the publication of a new list after the expiry of the minimum period of one year or till the expiry of three years whichever is earlier. Candidates will be advised for appointment against aforesaid vacancies and also against the vacancies, if any, reported during the currency of the lists.
- (ii) The selection in pursuance of the notification will be made on a revenue district basis, subject to the special conditions laid down in G.O. (Ms)No.154/71/PD dated, 27.05.1971. A candidate advised for appointment in one revenue district from the Ranked List prepared is not eligible for transfer to another district unless he/she completes five years continuous service from the date of commencement of service in the former district. Even if transfer is allowed after five years, it will be subject to the rules in G.O(P)No.36/91/P&ARD, dated 02.12.1991. Candidates already in Government service holding this post in any one district are prohibited from applying again for this post, but they can apply to higher posts when notified.
- (iii) *If there is any change in caste with respect to the entries in SSLC, then such changes is to be published in the gazette notification and the same along with the Community Certificate/Non creamy layer certificate issued by the Revenue authorities , is to be produced to prove their claim in application, at the time of One Time Verification or as and when required by the commission.*

5. Method of appointment : Direct Recruitment

6. Age : 19-36. i.e candidates born between 2.1.1982 and 1.1.1999 (both dates included) only are eligible to apply for this post. Usual age relaxation will be given to SC/ST & Other backward Communities.

Note :- For concessions allowed in upper age limit, subject to the condition that the maximum age limit shall in no case exceed 50 years, please see para (2) of the General Conditions under Part II of this Notification.

7. Qualifications :-

1. Minimum General Qualification of S.S.L.C standard.
and
2. Certificate in Electrical Engineering after having undergone a course of study of not less than one year from an Institution recognised by Government.. (Qualifications in Electrical Engineering are specified under Note :1 below.)

OR

City and Guilds Examination in Electrical Engineering London Institute in A.C of the Intermediate Grade.

(Certificate awarded after 31.3.1985 will not be accepted)

OR

M.G.T.E or K.G.T.E Certificate (Higher) in Electrical Light and power.

OR

Grade III Certificate as Electrician or Lineman from War Technical Training Centre.

Note:- 1 Qualifications in Electrical Engineering shall be any one of the following:

- i) The Certificate in Electrical Engineering issued by the Commissioner for Government Examination on behalf of the State Board of Technical Education after undergoing a course of one year duration.
- ii) National Trade Certificate in the Trade of Electrician issued by Government under the Craftsman Training Schemes through the Industrial Training Institute. (NTC)
- iii) Any other Certificate recognised as equivalent to any of the above qualifications or declared as equivalent to a Certificate in Electrical Engineering of not less than one year duration.

Note:- 2 (a) Those who claim equivalent qualification shall produce the respective Government Order to prove the claim at the time of One Time Verification or as required by the Commission.

(b) Rule 10 (a) ii of Part II KS & SSR is applicable.

8. Mode of submitting applications:-

Candidates must register as per ONE TIME REGISTRATION with the Official Website of Kerala Public Service Commission www.keralapsc.gov.in before applying for the post. Candidates who have registered can apply by logging in to their profile using their User-ID and password. Candidates must click on the Apply Now button of the respective posts in the Notification Link to apply for a post. The photograph uploaded should be one taken on or after 31/12/2010.

Name of the candidate and the date of taking photograph should be printed at the bottom portion. The photograph once uploaded meeting all requirements shall be valid for 10 years from the date of uploading. There is no change in other instructions regarding the uploading of photographs. No application fee is required. Candidates shall take a printout of the application by clicking the link Registration Card in their profile. Candidates are responsible for the correctness of the personal information and secrecy of password. Before the final submission of the application on the profile, candidates must ensure the correctness of the information on their profile. They must quote their User-ID for further communication with the Commission. Application submitted is provisional and cannot be deleted or altered after submission. The Application will be summarily rejected if noncompliance with the notification is found in due course of processing. Documents to prove Qualification, experience, Community, age etc. have to be produced as and when called for. Candidates who have AADHAAR Card should add AADHAAR Card as Identification Certificate proof in their profile.

10. Last date of receipt of applications **30.01.2019** Wednesday upto 12 midnight.
11. If Written Test/OMR/Online Test is conducted as part of this selection, candidates shall submit a confirmation for writing the examination through their One Time Registration profile. Such candidates alone can generate and download the Admission Tickets in the last 15 days till the date of Test. The applications of candidates who do not submit confirmation within the stipulated period will be rejected absolutely. The periods regarding the submission of confirmation and the availability of Admission Tickets will be published in the Examination Calendar itself. Information in this regard will be given to the candidates in their respective profiles and in the mobile phones registered in it.
