- (i) Candidates shall apply online only by One Time Registration available at the Kerala Public Service Commission website viz www.keralapsc.gov.in
 - (ii) The above vacancy is now in existence. The Ranked List will be prepared for the above district in pursuance of this notification. The Ranked list thus prepared and published by the Commission, shall remain in force for a minimum period of one year and a maximum period of three years provided the said list will not continue to be in force if a new list is published after the expiry of the minimum period of one year. Candidates will be advised for appointment against the aforesaid vacancy and also against the vacancies, if any reported during the currency of the list.
 - (iii) The selection in pursuance of this notification will be made on a Revenue District basis, subject to the special conditions laid down in G O (MS) No. 154/71/PD dated 27.05.1971. A candidate advised for appointment in one Revenue District from the Ranked List prepared is not eligible for transfer to another district unless he/she completes five years continuous service from the date of commencement of service in the former district. Even if transfer is allowed after five years, it will be subject to the rules in G.O.(P)No.36/91/P&ARD dated 02.12.1991. Candidates already in Government Service holding the same post in any one district are prohibited from applying again for this post, but they can apply to higher posts when notified.
 - (iv) Candidates should submit the application for this post to the above district, where the vacancy is existing and should note the name of the concerned District against the relevant column of the online application.
 - (v) 3% vacancies for the post shall be reserved for eligible Differently Abled

candidates vide GO (P) No.1/13/SJD dated 03.01.2013.

- (vi) If the community claim in the application differs from the community noted in S.S.L.C., then such changes are to be published in the Gazette on or before the date of verification of original documents and the same should be produced along with the Community Certificate/Non Creamy Layer Certificate issued by the Revenue Authorities at the time of One Time Verification or as and when required by the Commission.

5. Method of appointment : Direct Recruitment .
6. Age Limit : 19-36. Candidates should have been born between 02.01.1982 and 01.01.1999 (both dates included) are eligible to apply for the post. Usual age relaxation will be given to SC/ST & Other backward Communities.

Note: (1) For concessions allowed in upper age limit, subject to the condition that the maximum age limit shall in no case exceed 50 years, please see para (2) of the General Conditions under Part II of this Notification.

7. Qualifications :

- 1) National Trade Certificate in Painter Trade.
- 2) Must have atleast 5 years experience gained in Spray painting, hand painting, letter writing and Painting monogram etc. from a workshop after acquiring the technical qualification of NTC in Painter Trade. The experience gained from the workshop other than Government/Quasi Government must be registered under the Companies Act, S.S.I. Act or Co-operative Societies Act.

Candidates must register as per “ONE TIME REGISTRATION” with the Official Website of Kerala Public Service Commission 'www.keralapsc.gov.in' before applying for the post. Candidates who have registered can apply by logging in to their profile using their User-ID and password. Candidates must click on the 'Apply Now' button of the respective posts in the Notification Link to applying for a post. The photograph uploaded should be one taken after 31/12/2010. Name of the candidate and the date of taking photograph should be printed at the bottom portion. The photograph once uploaded meeting all requirements shall be valid for 10 years from the date of uploading. There is no change in other instructions regarding the uploading of photographs. No application fee is required. Candidates shall take a printout of the application by clicking the link Registration Card in their profile. Candidates are responsible for the correctness of the personal information and secrecy of password. Before the final submission of the application on the profile, candidates must ensure the correctness of the information on their profile. They must quote their User-ID for further communication with the Commission. Application submitted is provisional and cannot be deleted or altered after submission. The application will be summarily rejected if noncompliance with the notification is found in due course of processing. Documents to prove Qualification, experience, Community, age etc. have to be produced as and when called for. Candidates who have AADHAAR Card should add AADHAAR Card as Identification Certificate proof in their profile.
