THIRD NCA NOTIFICATION

Applications are invited online only by One Time Registration from qualified candidates belonging to Scheduled Tribe Community of Kerala State for selection to the undermentioned post in Kerala Government Service. Before applying for the post the candidate shall register as per One Time Registration Scheme through the official website of Kerala Public Service Commission.

The above vacancies are now in existence. The Ranked list published as per this notification will be valid until candidates are advised and appointed against the above vacancies earmarked for the above mentioned Community, but remain unfilled and also against the vacancies that may arise due to the paucity of candidates belonging to Scheduled Tribe community during the currency of the ranked list published on 04.02.2011 for the post. This is the Third NCA notification due to the non-availability of ST candidates for the post after the issuance of first NCA notification published in the Gazette dated 15.11.2013 (Category No.425/13), and the second NCA notification published in the Gazette dated 14.06.2016 (Category No.135/16).

Note:As per G.O.(P)No.61/2012/SWD dated 17.10.12, differently abled candidates with Locomotor disability/Cerebral Palsy, Blindness and Low vision are eligible to apply for this post. Candidates with Hearing impairment are not eligible to apply for this post as per the above G.O.

5.	Method of appointment	-	Direct Recruitment (From candidates belonging to Scheduled Tribe Community.)
Note :-	Applications submitted by candidates belonging to community other than the above mentioned community will be summarily rejected. Individual communication regarding rejection of their application will not be issued.		
6.	Age limit	-	21-47. Only candidates born between 02.01.1971 and 01.01.1997 (both dates included) are eligible to apply for this post.(Including the age relaxation as per para 2(i)of the general conditions)
(For other conditions regarding age relaxation please see Para 2 of the General Conditions) [Except Para 2(i)]			

7.	Qualifications	(1) Degree in modern medicine or equivalent qualification. [Equivalent qualification means those qualification recognised as equivalent by the Medical Council of India.] (2) Valid Registration with the Travancore-Cochin medical Council.

In the absence of candidates with the above qualifications, candidates with following qualifications as per mother notification will be considered.

- (1) M.B.B.S Degree.
- (2) Permanent Registration with the Travancore Cochin Medical Council.
(Candidates who have registered themselves with other State/Central Medical council may also apply, but they will have to get themselves registered under Travancore Cochin Medical Practitioners Act before joining duty.)

Note:- (1)Rule 10 a (ii) of Part II KS & SSR is applicable.

(2)Those who are appointed in the post should serve for four (4) years during the first ten years of their service (including the period of training) anywhere in India or any Foreign country under Defence Service or services connected with Defence. Those who have completed 45 years of age will be exempted from the above compulsory medical service.

(3) Candidates who claim equivalent qualification instead of qualification mentioned in the notification shall produce the relevant Government Order to prove the equivalency at the time of verification, then only such qualification shall be treated as equivalent to the prescribed qualification concerned.

(4) In the case of difference in original Caste/Community claimed in the application and that entered in SSLC book, the candidate shall produce a Gazette notification in this regard, along with Non Creamy Layer Certificate/Community Certificate at the time of certificate verification.

9. Mode of submitting Application:-

- a. Candidates must register as per ONE TIME REGISTRATION with the official Website of Kerala Public Service Commission www.keralapsc.gov.in before applying for the post. Candidates who have registered can apply by logging on to their profile using their User-ID and password. Candidates must click on the Apply Now button of the respective posts in the Notification Link to apply for a post. The Photograph uploaded should be taken after 31.12.2010. Name of the candidate and the date of photograph taken should be printed at the bottom portion. The photograph once uploaded meeting all requirements shall be valid for 10 years from the date of uploading. There is no change in other instructions regarding the uploading of photographs. No application fee is required. Candidates shall take a printout of the application by clicking the link Registration Card in their profile. Candidates are responsible for the correctness of the personal information and secrecy of password. Before the final submission of the application on the profile candidates must ensure correctness of the information on their profile. They must quote the User-ID for further communication with the Commission. Application submitted is provisional and cannot be deleted or altered after submission. The application will be summarily rejected if noncompliance with the notification is found in due course of processing. Documents to prove qualification, age, Community etc. have to be produced as and when called for.
- b. If a Written/OMR/Online Test is conducted as part of this selection, candidates shall submit a confirmation for writing the examination through their One Time Registration profile. Such candidates alone can generate and download the admission Tickets in the last 15 days till the date of Test. The applications of candidates who do not submit confirmation within the stipulated period, will be rejected absolutely. The periods regarding the submission of confirmation and the availability of Admission Tickets will be published in the Examination Calendar itself. Information in this regard will be given to the candidates in their respective profiles and in the mobile phone number registered in it.
- c. Candidates who have AADHAAR card should add AADHAAR Card as ID Proof in their profile.
