Applications are invited online only by '**One Time Registration**' from qualified candidates for appointment to the under mentioned post in Kerala State Co-operative Bank Limited. Candidates who have already registered can apply through their profile.

Note:- (i) The above vacancy is now in existence. The list of selected candidates published by the Commission pursuant to this notification will be valid until candidates are advised and appointed against the vacancies earmarked for Ezhava, Scheduled Caste communities but kept unfilled due to paucity of candidates during the currency of the Mother Ranked List published on 14/11/2016 for General Category (Category No. 101/2010). or three years from the date of publication of this NCA notified ranked list whichever is earlier. This is the first notification issued due to non-availability of qualified candidates belonging to the above communities.

(ii) The selection in pursuance of this notification will be made on statewide basis.

(iii) As per Rule 184 of KCS every person appointed to this post shall from the date on which he/she joins the duty to be on probation for a period of one years on duty within a continuous period of two years.

5. **Method of appointment** : Direct Recruitment from qualified candidates belonging to Ezhava, Scheduled Caste.

Note:- Applications submitted by candidates who are not belonging to communities. Other than Ezhava and Scheduled Caste will be rejected. Individual communication regarding the rejection of their applications for the above reason will not be issued.

6. **Age** :
- 18-48 years. Ezhava**- Candidates born between 02.01.1970 and 01.01.2000 (Both dates included) are only eligible for the post.
- 18-50 years. SC** - Candidates born between 02.01.1968 and 01.01.2000 (Both dates included) are only eligible for the post.
- (Age relaxation for community included)

For other conditions regarding age relaxations please see Part 2 of the General Conditions)

Note:-

For concession allowed in upper age limit subject to the condition that the maximum age limit shall in no case exceed 50 years, please see para (2) of the General Conditions under part II of this Notification. Relaxation of age will be allowed to all provisional employees of the twenty nine Co-operative institutions mentioned in G. O. (P) No. 41/98 dated 09.03.1998 (whether they continue in service or relieved from service) who have been appointed through the Employment Exchange to the extent of their provisional service provided they possess a minimum service of one year in the provisional appointment. The maximum period of relaxation allowed to such persons will be five years. Once they get appointment on regular basis, the concession will not be available for further appointment to any other post. The candidates who are entitled to the above concession shall note the details there of in the respective column of the application and submit certificate (original) obtained from the Head of Office or Head of Department or Appointing Authority of the Co-operative Institutions concerned, when the Commission calls for. The certificate should contain all the relevant particulars such as the post in which the applicant has/ had provisional service, the scale of pay, name of the Co-operative Institution in which he/ she has/ had worked, the date of commencement of provisional service and the date of termination of the provisional service. It should also be noted in the certificate that the applicant is not holding regular appointment under the Co-operative Institution. The original certificate thus produced will not be returned to the candidate.

7. Qualifications:

Master's Degree in Business Administration or any other equivalent qualification, in Banking or Finance as the Main Subject OR M.Com recognized by Universities in the State OR M.Sc. (Co-operation and Banking) of Kerala Agricultural University.

OR

Membership of Institute of Chartered Accountants of India with experience of the not less than 5 years in Managerial Supervisory Cadre in Kerala State Co-operative Bank/Kerala State Co-operative Agricultural and Rural Development Bank/District Co-operative Bank/Nationalised Banks/Scheduled Banks/Government/Quasi Government Institutions/Public Limited Companies in Public Sector.

- (1) In the absence of above qualification the candidates possessing the qualification in mother notification as mentioned below also be accepted to this post.
- (2) Masters Degree in Business Administration or any other equivalent qualification recognized by the Universities in Kerala.

OR

Membership of the Institute of Chartered Accountants of India.

OR

Membership of the Institute of Cost and Works Accountants of India.

- (3) Experience of not less than three years in Managerial/Supervisory Cadre in Co-operative Institutions/Scheduled Banks/Govt/Quasi Government Institutions/Public Limited Companies.

Note :- 1) The existing employees who possess MBA/CA/CWA Qualification will be allowed age relaxation of 5 years to apply for direct recruitment.

2) Rule 10 (a) ii of Part II of the & KS&SSR is applicable.

3) Application will be accepted after uploading Experience Certificate at the time of the submission of the application.

- 4) Those candidates who have claimed equivalency for qualifications should produce the Government order proving the same at the time of certificate verification in order to consider as equivalent.
- 5) If the caste of candidates is wrongly mentioned in their SSLC book, they should claim their original caste in their applications and should produce community/NCLC certificate issued from concerned revenue authority and the Gazette Notification for the same at the time of certificate verification.

The Experience Certificate shall be countersigned by the Controlling Officer noted below:

- a) **Co-operative Institutions** : Joint Registrar of Co-operative Societies in the respective district.
- b) **Scheduled Banks** : Officers not below the rank of Regional Manager of the concerned bank.
- c) **Government** : Head of the Department/Competent Authority of the (concerned) department.
- d) **Quasi Government Institutions/Public Limited Companies** : Head of the Department (concerned) of the Industrial Department/Labour Department. (The genuiness of the experience certificate shall be examined and action as per rules will be taken against those who issue bogus certificate and those candidates who produce such certificate).

Candidates shall register as per 'ONE TIME REGISTRATION ' system on the Official Website of Kerala Public Service Commission 'www.keralapsc.gov.in' for applying for the post. Candidates who have registered shall apply by logging on to their profile using their User- ID and password. Candidates shall click on the 'Apply Now' button of the respective post in the Notification link while applying for a post. The photograph uploaded should be one taken after 31/12/2010. Name of the candidate and the date of taking photograph should be printed at the bottom portion. The photograph once uploaded meeting all requirements shall valid for 10 years from the date of uploading. There is no change in other instructions regarding the uploading of photographs. No application fee is required. Candidates can view and have a print-out of the details in the profile if required, by clicking the link Registration Card. Candidates are responsible for the correctness of the personal information and secrecy of password. Before applying for a post, candidates must ensure correctness of the information in their profile. They shall quote the User- ID for further communication with the Commission. Applications once submitted will be received as provisional and particulars shall not be deleted or altered after submission. Applications submitted not in accordance with the conditions of the notification will be summarily rejected.
