Applications are invited online only by One Time Registration exclusively from qualified candidates belonging to reservation group of Scheduled Tribe Community of Kerala State for selection to the undermentioned post.

1. Department : Education

2. Name of post : Part Time Junior Language Teacher (Arabic)-LPS

3. Scale of pay : `18,000-41,500/-

4. Number of vacancies : <u>District wise</u>

Palakkad – Scheduled Tribe - 01 (One)

Fourth Re-notification of the post notified in the Gazette date 15.12.2010,as Category No.401/10,and in Gazette dated 31.12.2012 as Category No.728/12 and in Gazette dated 29.09.2015as Category No.359/15

**Note:-** (i) Conventional type applications will be summarily rejected. Candidates shall apply online only by One Time Registration <a href="https://www.keralapsc.gov.in">www.keralapsc.gov.in</a>.

- (ii) Applications submitted by candidates belonging to the community other than those notified will be summarily rejected. No rejection memo will be issued .
- (iii) A Ranked List will be prepared for Palakkad District in pursuance of this notification. Ranked List thus prepared and published as per this notification shall remain in force for a period of three years or until candidates are advised and appointed against the vacancies earmarked for the above community, but remain unfilled due to paucity of candidates during the currency of the Ranked List published for the post in the following district which ever is earlier

- (iv)Candidates belonging to the above reservation community shall submit application for this post to the District Officer, Palakkad and shall note the name of that district against the relevant column in the online application.
- (v)The selection in pursuance of this notification will be made on a revenue district basis, subject to the special conditions laid down in G. O (MS.) No. 154/71/PD dated 27.05.1971. A candidate advised for appointment in one revenue district from the Ranked List prepared is not eligible for transfer to another district. Even if transfer is allowed after five years, it will be subject to the rules in G.O (Ms.) No. 4/61/PD dated 02.01.1961. Candidates already in Government service holding this post in any one district are prohibited from applying again for this post, but they can apply to higher posts when notified.

- (vi) If the community claim in the application differs from the community noted in SSLC, then such changes are to be published in the gazette and the same should be produced along with the Community Certificate/Non creamy layer certificate issued by the Revenue authorities at the time of One Time Verification or as and when required by the commission.
- 5. Method of appointment :- Direct Recruitment (From above mentioned reservation group of Community only).In the absence of Scheduled Tribe candidates , the candidates belonging to Scheduled Caste Community will be considered .
- 6. Age Limit

1)18-45 . Only Candidates born between 02.01.1973 and 01.01.2000 (both dates included) are eligible to apply for this post.

(Including the relaxation as per para 2(i) of General Conditions)

Note:- For concessions allowed in upper age limit, subject to the condition that the maximum age limit shall in no case exceed 50 years, please see para (2) of the General Conditions under Part II of this Notification (except para 2(i)).

### 7. Qualifications:-

A Degree in Arabic conferred or recognised by the Universities in Kerala.

OR

A Title of Oriental Learning in Arabic awarded or recognized by the Universities in Kerala

OR

A Pass in SSLC Examination conducted by the Commissioner for Government Examinations. Kerala with Arabic under Part I and II first Language.

OR

(A) A Pass in SSLC examination conducted by the Commissioner for Government Examinations. Kerala or its equivalent

AND

(B) A Pass in Arabic Munshi Examination (Higher ) conducted by the Commissioner for Government Examination, Kerala

OR

A Pass in Arabic Munshi Examination (Lower ) conducted by the Commissioner for Government Examination, Kerala

OR

A Pass in Arabic Teachers Examination conducted by the Commissioner for Government Examinations, Kerala

OR

A Pass in Arabic Entrance Examination of the Kerala/Calicut Universities.

(2) Must have passed the Kerala Teacher Eligibility Test (K-TET) for this post conducted by the Government of Kerala

Exemption:- Candidates who have qualified CTET/NET/SET M.Phil./Ph.D./M.ED. In the respective subjects are exempted from acquiring TET [G.O( P) No. 145/16/G.Edn dated 30.08.2016 and G.O (p) No. 206/16/G.Edn dated 08.12.2016]

M.Phil in the concerned subject be the one awarded by any of the Universities in Kerala or recognised as equivalent by any of the Universities in Kerala. Candidates claiming equivalent qualification should produce relevant Government orders during verification to prove that the qualification claimed is equivalent to the prescribed qualification for the post.

NB:- Rule 10 1 (ii) of KS & SSR will be applicable.

- 8. Special Concessions regarding appointment and Age Limit :-
  - (i) Preference will be given as laid down in G.O (Ms) No. 50/70/PD dated 12.02.1970 and G.O (Ms) No 9/78/G.Edn. Dated 21.01.1978 to the wives of Jawans in the matter of recruitment as Teachers, if they possess the prescribed qualifications. Soldiers in active service and those working in Base Establishment are included under the term 'Jawans'. Wives of jawans mush claim the same through the weightage and preferences link provided in their One Time Registration Profile and give details in the space provided. Such candidates should obtain proper certificates from the Officer Commanding stating the name, military rank and military address of their husbands and produce the same as and when required by the Commission [G.O (Ms) No. 509/64/Edn.dated 19.09.1964, G.O (ms) no. 614/65/Edn. Dated 09.11.1965 and G.O (Ms) No 243/66/Edn. Dated 27.05.1966]
  - (ii) First Class Scouts and Guides will be given preference in the matter of appointment as Teachers [G.O (Ms) No. 122/75/G.Edn dated 27.05.1975]

Note:- The candidates who are eligible for the above preferences in upper age limit or concessions by virtue of any of the reason mentioned in Para 2 of the General Condition should claim the same through the "weightage and preferences" link provided in their One Time Registraion Profile and give details in the space provided. The applications of candidates who are eligible for concession in upper age limit and who do not claim the same, are liable to be rejected presuming that they are over aged candidates. Upper age limit after allowing the relaxation as per the rule should not exceed 50 years of age (see para 2 of General Conditions).

### 9. Mode of sending Application :-

Candidates must register as per 'ONE TIME REGISTRAION' with the Official Website of Kerala Public Service Commission 'www.keralapsc.gov.in' before applying for the post. Candidates who have registered shall apply by logging in to their profile using their User ID and password. Candidates must click on the 'Apply Now' button of the respective posts in the Notification link to apply for a post. The photograph uploaded should be one taken after 31.12.2010. Name of the candidate and the date of taking photograph should be printed at the bottom portion. The photograph once uploaded meeting all requirements shall be valid for 10 years from the date of uploading of the photograph. There is no change in other instructions regarding the uploading of photographs. No application fee is required. Candidates can view the details in their profile by clicking the link 'Registration Card' in their profile. A print out of the same can be taken if needed. Candidates are responsible for the correctness of the personal information and secretary of password. Before the final submission of the application on the profile candidates must ensure correctness of the information on their profile. They must quote the User-ID for further communication with the Commission. Application will be summarily rejected if noncompliance with the notification is found in due course of processing. Documents to prove qualification, experience, community, age etc. have to be produced as and when called for.

- 12. If written /OMR/Online Test is conducted as part of this selection, candidates shall submit a confirmation for writing the examination through their One Time Registration profile. Such candidates alone can generate and download the Admission Tickets in the last 15 days till the date of Test. The applications of candidates who do not submit confirmation within the stipulated period, will be rejected absolutely. The periods regarding the submission of confirmation and the availability of Admission Tickets will be published in the Examination Calender itself. Information in this regard will be given to the candidates in their respective profiles and in the mobile phone number registered in it.
