1. This notification will be applicable to selection to the above mentioned post in all the universities mentioned in Rule 2a (i to xiii) of the Kerala Public Service Commission (Additional Functions as respects the Service under the Universities) Act 2015 and of the Universities added in this Act as per law in due course.

2. Only one ranked list will be published in pursuance of this notification and candidates will be advised from that list against all the vacancies reported for the post from all the Universities mentioned above. As such a candidate need send only one application. Candidates will be advised for recruitment to each University according to the order in which vacancies are reported from each University and in accordance with the ranks secured by them subject to the rules of reservation and rotation in force. Once advised his/her turn will be over and he/she will have no further claim for being considered for appointment from the ranked list to another university. As common ranked list is prepared for more than one university on the basis of a common written examination, a candidate appointed in a university and relieved for want of vacancy can register his/her name in the office of Kerala Public Service Commission and in such case he/she will be advised for appointment against the next vacancy reported from any of the above mentioned university. His/her service in the former university will be counted for probation in the latter university. For reappointment in the present university itself, no registration is necessary but one has to wait till vacancy arises in that appointment to any university. Candidates will have no right to claim initial particular university.

Note:- 1. Candidates who claim equivalent qualification instead of qualification mentioned in the notification shall produce the relevant Government Order to prove the equivalency at the time of verification, then only such qualification shall be treated as equivalent to the prescribed qualification concerned.

2. In the case of difference in original caste/community claimed in the application and that entered in SSLC book, the candidate shall produce a Gazette notification in this regard, along with Non creamy layer Certificate/community certificate at the time of certificate verification.

8. Probation:

The candidates selected to the post shall be on probation for a period of two years on duty within a continuous period of three years during which the candidates selected shall pass Secretariat Manual and Accounts test.

9. Mode of submitting Application:-

Candidates must register as per 'ONE TIME REGISTRATION' with the Official Website of Kerala Public Service Commission www.keralapsc.gov.in before applying for the post. Candidates who have registered can apply by loging on to their profile using their User-ID and password by clicking on the 'Apply Now' button of the respective posts in the Notification Link. The photograph uploaded in the profile should be one taken after 31.12.2010. Name of the candidate and the date of taking photograph should be printed at the bottom portion in white background. The photograph once uploaded meeting all requirements shall valid for 10 years from the date of uploading. There is no change in other instructions regarding the uploading of photographs. No application fee is required. Candidates shall take a printout of the application by clicking the link Registration card in their profile. Candidates are responsible for the correctness of the personal information and secrecy of password. Before the final submission of the application on the profile candidates must ensure correctness of the information on their profile. They must quote the User-ID for further communication with the Commission. Application once submitted is received as provisional and the details cannot be deleted or altered after the last date of receipt of applications. The application submitted not in accordance with the conditions stipulated in the notification will be summarily rejected in due course of processing. Documents to prove qualification, experience, community, age etc.have to be produced as and when called for. The profile correction made by candidate or in the office of KPSC on request after the last date fixed for the receipt of application will not reflect in the application. Such corrections will be in effect on the date on which correction have made.

10.Candidate shall submit their confirmation for writing the examination through their One Time Registration profile on or before the last date fixed for giving conformation. Candidates who successfully submit their confirmation can generate and download the Admission Ticket. The candidates who fail to submit their confirmation within the stipulated time allowed will not get the chance to attend the exam and their applications will be summarily rejected. The last date for submitting confirmation and generation of admission ticket will be published in the official website of Kerala Public Service Commission www.keralapsc.gov.in and in the One Time Registration profile of the candidates.
