FIRST NCA NOTIFICATION

Applications are invited online only exclusively from qualified candidates belonging to the reservation group of communities of Kerala State viz **Scheduled Caste** for NCA vacancies for the selection to the following post. Applications shall be submitted through the official website of the Commission after ONE TIME REGISTRATION. Candidates who have registered can apply through their profile. The photo uploaded through One Time Registration should be taken on or after 31.12.2010. The name of candidate and date of photograph taken should be printed in the bottom of the photograph. The uploaded photograph will be having a validity of 10 years from the date of taking the photograph.

- 1 Name of concern : **Plantation Corporation of Kerala Limited.**
- 2 Name of Post : **Medical Officer (I NCA- SC)**
- 3 Scale of pay : ` 12930 – 20250
- 4 No of Vacancies : **1 (One) – (SC)**

Note:

- i) *The number of candidates to be included in the Short List/Probability List of the above post will be decided as per the availability of admitted applications.*
- ii) *The above vacancy is now in existence. The Ranked list published as per this notification will be valid until candidates are advised and appointed against the vacancy earmarked for above community during the currency of the Ranked List published on **13/07/2017** (Category No. **161/2013**) or three years from the date of Publication of this NCA ranked list whichever is earlier.*
- iii) *The Kerala Public Service Commission shall have the power to cancel the advice for appointment of any candidate to the above post, if it is subsequently found that such advice was made under some mistake. On such cancellation the appointing authority shall terminate the service of the candidates, provided that the cancellation of advice for appointment by the Commission and subsequent termination of service of the candidate by the appointing authority shall be made within the period of probation or 240 days from the date of joining duty whichever is earlier.*

- 5 Method of appointment : Direct Recruitment (from candidates belonging to SC community only).
- 6 Age : 21-41, Only candidates born between 02.01.1977 and 01.01.1997 (both dates included) are eligible to apply for this post. (Including age relaxation to the community mentioned above).

Note: *The provisional hands working in the above concern will be given age relaxation to the extent of their provisional service put in subject to a maximum of five years from the upper age limit provided they are within the prescribed age limit on the date of their first appointment in the above concern. But the regular employees of the concern are not eligible for the above concession for further appointment. The provisional hands should obtain a certificate showing the period of their provisional service in the concern and shall produce the same as and when required by the Commission. It would also be clearly specified in the Certificate that they were not working in the regular service of the concern. (For other conditions regarding the age relaxations please see para 2(i), (ii), (iii), (iv), (vii) & (xii) of the General Conditions).*

- 7 Qualifications : 1) MBBS
2) One year House Surgency in an approved Hospital having not less 100 beds with separate Medical and Surgical Department or one year service as Demonstrator/Tutor in a Medical College.
3) Registration in class 'A' of Modern Medicine with the Kerala Medical Council. Persons who have registered themselves with other State/Central Medical Council may also apply. But they will have to get themselves registered under the T.C. Medical Practitioners Act before they join duty.

Note: *Rule 10(a)ii of Part II KS&SSR regarding qualification is applicable for this selection.*

2. *Candidates who claim equivalent qualification instead of qualification mentioned in the notification shall produce the relevant Government Order to prove the equivalency at the time of verification, then only such qualification shall be treated as equivalent to the prescribed qualification concerned.*

3) In the case of difference in original caste/community claimed in the applications and that entered in SSLC book, the candidate shall produce a Gazzatte notification in this regard along with Non creamy Layer certificate/caste certificate at the time of certificate Verification.

8 **Mode of submitting applications**

Before applying for the post, candidates should register as per "ONE TIME REGISTRATION" scheme through the Official Website of Kerala Public Service Commission www.keralapsc.gov.in Those who have already registered can apply by logging in to their profile using his/her User ID and password. There is no change in other instructions regarding the uploading of photographs. No application fee is required. Candidates can view, rectify defects and print the details in the registration card by clicking the link **Registration Card** after entering the home page. Candidates are responsible to ensure correctness of the personal information and secrecy of password and they shall keep in mind the user ID for further communication with the Commission. Applications which are submitted not in accordance with the instructions given in the website will be summarily rejected. Documents to prove Qualification, age, community etc have to be produced as and when called for. **"Candidates who have AADHAAR Card should add AADHAAR Card as I.D proof in their profile".**

9 Last date of receipt of applications : **30.01.2019** Wednesday upto 12.00 Midnight.

 - (c) If a written/OMR/Online Test is conducted as part of this selection, candidates shall submit a confirmation for writing the examination through their One Time Registration Profile. Such candidates alone can generate and download the Admission Tickets in the last 15 days till the date of Test. The applications of candidates who do not submit confirmation within the stipulated period, will be rejected absolutely. The periods regarding the submission of confirmation and the availability of Admission Tickets will be published in the Examination Calendar itself. Information in this regard will be given to the candidates in their respective profiles and in the mobile phones registered in it.
