Applications shall be submitted online only on the official website of the Commission after "ONE TIME REGISTRATION". Candidates who have already registered can apply through their profile. - (i) The above vacancy is now in existence. - (ii) The Kerala Public Service Commission shall have the power to cancel the advice for appointment of any candidate to the above post, if it is subsequently found that such advise was made under some mistake. On such cancellation the appointing authority shall terminate the service of candidate, provided that, the cancellation of advice for appointment by the Commission and subsequent termination of service of the candidate by the appointing authority shall be made within the period of probation or 240 days from the

date of joining duty whichever is earlier.

6 Age : 18-36. Only candidates born between 02.01.1982 and

01.01.2000 (both dates included) are eligible to apply for this post. Other Backward Communities and SC/ST candidates are eligible for usual age

relaxation.

Note:-

3% of the vacancies are reserved for the eligible differently abled candidates with Locomotor Disability/Cerebral Palsy ,Hearing Impairment for the above post. Differently abled candidates with Low vision are not eligible.(G.O (P) No.1/13/SJD dated 03.01.2013). The provisional hands working in the above concern will be given age relaxation to the extent of their provisional service put in subject to a maximum of Five years from the upper age limit provided they are within the prescribed age limit on the date of their first appointment in the above concern. But the regular employees of the concern are not eligible for the above concession for further appointment. The provisional hands should obtain a certificate showing the period of their provisional service in the concern and shall produce the same as and when required by the Commission. It would also be clearly specified in the certificate that they were not working in the regular service of the concern.

- 4. Pass in DCA Course (6 months) or equivalent qualification.

- (2) Candidates who claim equivalent qualification instead of qualification mentioned in the notification shall produce the relevant Government Order to prove the equivalency at the time of verification, then only such qualification shall be treated as equivalent to the prescribed qualification concerned.
- (3) In the case of difference in original caste/community claimed in the application and that entered in SSLC Book, the candidate shall produce a Gazette Notification in this regard, along with Non Creamylayer Certificate/Community Certificate at the time of Certificate Verification.

Candidates are responsible for the correctness of the personal information and secrecy of password. Before applying for a post, candidates must ensure correctness of the information in their profile. They must quote the User- ID for further communication with the Commission. Applications once submitted will be received as provisional and particulars shall not be deleted or altered after submission. Applications submitted not in accordance with the conditions of the notification will be summarily rejected if non compliance with the notification is found in due course of processing. Documents to prove qualification, community, age etc. have to be produced as and when called for.
- (b) If a written/OMR/Online Test is conducted as part of this selection, candidates shall submit a confirmation for writing the examination through their One Time Registration Profile. Such candidates alone can generate and download the Admission Tickets in the last 15 days till the date of Test.
