The following list contains the names of the candidates found suitable on the basis of the result of the Objective Type Test (OMR Valuation) held on 13/07/2013 and verification of documents that followed for selection to the post of JUNIOR ASSISTANT/ASSISTANT Gr.II/LDC etc. on ₹ (Scale of Pay as prescribed for the post by the concerned Company/Corporation/Board) in KSRTC/KLSDB/SFCK etc. (Category No. 490/2011) in State arranged in the order of merit.

The Ranked List is brought into force with effect from 29.09.2015. The Ranked List will be in force till the publication of a new Ranked List after the expiry of a minimum period of one year or till the expiry of three years which ever is earlier. Candidate will be advised for appointment in accordance with the rules and orders regarding reservation and rotation as amended from time to time, if applicable, against vacancies reported to the Commission during the pendency of this list. As the advice for appointment depends on the occurrence of vacancies, there is no guarantee that all candidates included in the list will secure appointment. The candidates remaining in the list at the time of cancellation will have no claim at all for appointment on the basis of the inclusion of their names in the list.

Candidates who wish to obtain a photocopy of their OMR answer sheet (Part A & Part B) relating to this selection shall remit the fees of Rs.300/- in any of the Treasuries in the State (head of account:0051 PSC-800-State PSC-99-other receipts). The duly filled in application in the prescribed form (available from the Commission's website [www.keralapsc.gov.in](http://www.keralapsc.gov.in)) along with the original chalan should be submitted to the Deputy Secretary (Examinations), Kerala Public Service Commission, Pattom, Thiruvananthapuram-4 within 45 days from the date of approval of this ranked list (on or before 16/11/2015). A copy of an answer sheet will be issued only once to a candidate. Copies of OMR answer sheets invalidated due to any defect will not be issued. Candidates are prohibited from applying for a copy of an answer sheet which is not their own, and legal proceedings will be initiated against those who do so.

A period of forty five days time to apply for rechecking of Answer Scripts will be allowed to candidates with effect from the date of approval of Ranked List. The candidates can avail only one chance after the approval of Ranked List. Candidates desiring to get their answer script rechecked pertaining to the Objective Type Test (OMR Valuation) held for selection to the post may apply for rechecking within 45 days from the date of approval of the Ranked List (on or before 16/11/2015). Applications for rechecking of answer scripts should be submitted in the prescribed

form available free of cost from the Enquiry sections of the various offices of the Commission or its photocopy, or downloaded and printed in A4 size paper from the Commission's Website [www.keralapsc.gov.in](http://www.keralapsc.gov.in) or photocopied there from. Applications submitted in any other manner will not be considered. The application for rechecking along with original chalan receipt for the prescribed fee for Rs.75/- under the head of account "0051 - PSC 105- State PSC 99 - Examination Fee" addressed to the Deputy Secretary (Examinations), Kerala Public Service Commission, Pattom, Thiruvananthapuram-4, should reach the office within 45 days from the date of approval of this ranked list (on or before 16/11/2015). Application for rechecking received after the stipulated time will not be entertained and fee once remitted will not be refunded on any account.

Any candidate can relinquish his/her right for appointment in writing duly attested by a Gazetted Officer of State/Central Government with signature, name, designation and Office seal. The request for relinquishment received within 15 days from the date of publication of Ranked List will be honoured against the requisitions of vacancies that are pending with the Commission up to the finalization of the Ranked List. After the publication of the Ranked List, the request for relinquishment will be considered only if such request is received on or before the date of receipt of requisition, based on which he/she is to be advised.

Entries put in Community column are based on the communities specified by the candidates in their application forms and proved by them with necessary documents. The candidates whose communities have not been correctly noted in the list as proved by them in their application should intimate the fact to the **Regional Officer, Kerala Public Service Commission, Regional Office, Ernakulam** within one month from the date of publication of this list to get the benefit of reservation to which they are entitled to. In the absence of timely information regarding discrepancies if any, the candidates will be advised as incorporated in the list.

Willingness to be appointed in four companies has been entered against the name of candidates in the Ranked List as per the Form of Willingness and declaration submitted by them at the time of certificate verification. Any correction in willingness noted in Ranked List as claimed by the candidates shall also be intimated to the undersigned within one month from the date of publication of this list, provided any enhancement/revision of willingness actually tendered will not be entertained under any circumstances.
