**NOTIFICATION**

The following list contains the names of candidates found suitable by the Commission on the basis of the results of the Objective Type (OMR) Test held on 30/04/2016 for the post of **LOWER DIVISION TYPIST (By Transfer)** on Rs 9940-16,580/- in Various Departments in Thrissur District arranged in the order of merit. The Ranked List is published on the basis of the Gazette Notification for the post dated 10/09/2014 with Category No. 389/2014. The Ranked List is brought into force with effect from 31.08.2016. The candidates included in the list shall be advised against the 10% vacancies from low paid employees in the Kerala State Subordinate Service (including Last Grade Servants) for them purely on the basis of merit. In case the candidates included in the Ranked List couldn't secure appointment before the expiry of the Ranked List, the names of such candidates will be included at the top of the new Ranked List of the Low paid employees drawn up by the Commission subsequently in the same order and they will be advised for appointment accordingly (Vide G.O (P) No. 39/89/P&ARD dated 08/12/1989)

According to the existing procedure, re-valuation of answer script is not allowed. But rechecking of marks will be done on payment of **Rs.75/- (Rupees Seventy Five only)**. The fee should be remitted in any one of the Treasuries in the State under the Head of Account **“0051 PSC 105 STATE PSC - 99 EXAMINATION FEE”** and original chalan enclosed with the application. Application for re-checking of answer scripts should be submitted in the prescribed form available free of cost from the Enquiry Section of the various offices of the Commission or its photocopy or downloaded and printed in A4 size paper from the Commission’s website: [www.keralapsc.gov.in](http://www.keralapsc.gov.in) or photocopied therefrom. Applications submitted in any other manner will not be considered. The original challan receipt together with the application for re-checking should reach the **District Officer, K.P.S.C District Office, Thrissur** with 45 days from the date on which this Ranked List is brought into force. The fee once remitted will not be refunded on any account.

Candidates who wish to obtain a photocopy of their OMR answer sheet (Part A & B relating to this selection shall remit a fee of Rs. 300/- by way of chalan in any of the Treasuries in the State Head of Account **“0051-PSC-800 STATE PSC - 99 OTHER RECEIPTS”**. The duly filled up application in the prescribed form (available from the commission’s website) along with the original chalan should be submitted to the **District Officer, K.P.S.C. District Office, Thrissur** within 45 days from the date on which the Ranked List is brought into force. A copy of the answer sheet will be issued only once to a candidate. Candidates are prohibited from applying for copy of answer sheet which is not their own, and legal proceedings will be initiated against those who do so.

Any candidate can relinquish his/her right for appointment in writing duly attested by a Gazetted Officer of State/Central Government with signature, Name, Designation and Office Seal. The request for relinquishment received within 15 days from the date of publication of the Ranked List will be honoured against the requisitions of vacancies that are pending with the Commission upto the finalisation of the Ranked List. After the publication of the Ranked List, the request for relinquishment will be considered only if such request is received on or before the date of receipt of requisition, based on which he/she is to be advised.

Valid applications for rechecking/ photocopy of answer script addressed to **District Officer, K.P.S.C District Office, Thrissur** Shall reach this office within 45 days from the date on which the Ranked List is brought into force. The last date for receipt of applications for rechecking/photocopy of answer script is 14.10.2016. Application for rechecking/photocopy received after the prescribed time limit and not in the prescribed form will not be entertained.
