NOTIFICATION

The following is the Ranked List of candidates for selection to the post of Last Grade Servants (SR from SC/ST only) (Category No: 309/2013) on Rs. 8,500-13,210/- in Various Departments in Kozhikode District, notified in the Gazette dated 12.09.2013 found suitable by the Commission and arranged in the order of merit based on the OMR Test held on 13.08.2014. This Ranked List is brought into force with effect from 21.03.2016.

The Ranked List will be in force till the publication of a new ranked list after the expiry of a minimum period of one year or till the expiry of three years whichever is earlier. Candidates from the list will be advised for appointment in accordance with the rules and orders regarding reservation and rotation as amended from time to time, if applicable, against vacancies reported to the Commission during the pendency of the list. As the advice for appointment depends on the occurrence of vacancies, there is no guarantee that all candidates included in the list will secure appointment. The candidates remaining in the list at the time of cancellation will have no claim at all, for appointments on the basis of the inclusion of their names in the list.

According to the existing procedure, re-valuation of Answer Script is not allowed. But rechecking of marks will be done on payment of **Rs. 75/-**. The fee should be remitted in any one of the treasuries in the State under the head of account "0051 PSC - 105 State PSC- 99 **Examination Fee**" and original chalan enclosed with the application. Applications for rechecking of answer scripts should be submitted in the prescribed form available free of cost from the enquiry sections of the various offices of the Commission or its photocopy or downloaded and printed in A4 size paper from the Commission's website / www.keralapsc.gov.in / or photocopied therefrom. Applications submitted in any other manner will not be considered. The original chalan receipt together with the application for rechecking should reach the District Officer, K.P.S.C District Office, Civil Station (PO), Kozhikode within 45 days from the date on which this Ranked List is brought into force. The fee once remitted will not be refunded on any account.

Candidates who wish to obtain a photocopy of their OMR answer sheet (Part A & Part B) relating to this selection shall remit a fee of **Rs**. 300/- by way of chalan in any of the treasuries in the State (Head of Account 0051 PSC-800 State PSC - 99 other receipts). The duly filled up application in the prescribed form (available from the commission's website) along with the original chalan should be submitted to the **District Officer**, **K.P.S.C District Office**, **Civil Station** (PO), **Kozhikode** within 45 days from the date on which the Ranked List is brought into force. A copy of the answer sheet will be issued only once to a candidate. Candidates are prohibited from applying for copy of answer sheet which is not their own, and legal proceedings will be initiated against those who do so.

"Any candidate can relinquish his/her right for appointment in writing duly attested by a Gazetted Officer of State/Central Government with signature, name, designation and Office Seal. The request for relinquishment received within 15 days from the date of publication of Ranked List will be honoured against the requisitions of vacancies that are pending with the Commission upto the finalization of Ranked List. After the publication of the Ranked List, the request for relinquishment will be considered only if such request is received on or before the date of receipt of requisition, based on which he/she is to be advised."

Valid applications for rechecking/ photocopy of answer script addressed to **District Officer**, **K.P.S.C District Office**, **Civil Station (PO)**, **Kozhikode** shall reach this office within **45** days from the date on which the Ranked List is brought into force. The last date for receipt of applications for rechecking / photocopy of answer script is **04.05.2016**. Application for rechecking/ photocopy received after the prescribed time limit and not in the prescribed form will not be entertained.
