**NOTIFICATION**

The following is the Ranked list of candidates for selection to the Post of **PROCESS SERVER/ DUFFEDAR/ COURT KEEPER (SR From ST ONLY)** in **JUDICIAL DEPARTMENT** in Malappuram District, notified in the Gazette dated 16.07.2012 (Cat.No.377/12) on **Rs.8730-13540**/found suitable by the Commission and arranged in the order of merit based on the OMR Test held on 12.07.2014. This ranked list is brought into force with effect from **27.06.2016**.

The Ranked List will be in force for a minimum period of one year and a maximum period of three years from the date of finalisation of the Ranked List provided that the said list will not continue to be in force if a new Ranked List after the expiry of the minimum period of one year is published. Candidates from this list will be advised for appointment in accordance with the rules and orders regarding reservation and rotation as amended from time to time, if applicable, against vacancies reported to the Commission during the pendency of the list. As the advice for appointment depends on the occurrence of vacancies, there is no guarantee that all candidates included in the list will secure appointment. The candidates remaining in the list at the time of cancellation will have no claim at all for appointment on the basis of the inclusion of their names in the list.

The entries put in column 8 are based on the communities specified by the candidates in their application forms and proved by them with necessary documents. The candidates whose communities have not been correctly noted in the list as proved by them should intimate the fact to the District Officer, Kerala Public Service Commission District Office, Malappuram within one month from the date of publication of the list to get the benefit of reservation to which they are entitled to. In the absence of timely information regarding discrepancies, if any, the candidates will be advised as incorporated in the list.

Candidates who wish to obtain a photocopy of their OMR answer sheet (Part A & Part B) relating to this selection shall remit the fee of Rs.300/in any of the Treasuries in the State (Head of account: 0051 PSC800State PSC99 other receipts). The duly filled in application in the prescribed form (available from the Commission's website ([www.keralapsc.gov.in](http://www.keralapsc.gov.in))) along with the original chalan should be submitted to **The District Officer, Kerala Public Service Commission District Office, MALAPPURAM** within 45 days from the date on which this ranked list is brought into force. A copy of an answer sheet will be issued only once to a candidate. Candidates are prohibited from applying for a copy of an answer sheet which is not their own, and legal proceedings will be initiated against those who do so. The last date for receipt of applications is **10.08.2016**. Applications received after the prescribed date will not be entertained.

According to the existing procedure revaluation of Answer Script is not allowed but answer script can be rechecked. A period of 45 days time to apply for rechecking of Answer Scripts will be allowed to candidates with effect from the date on which this Ranked List is brought into force. The candidates can avail only one chance.

Applications for rechecking of answer scripts should be submitted in the prescribed form available free of cost from the Enquiry sections of the various offices of the Commission or its photocopy, or downloaded and printed in A4 size paper from the Commission's Website [www.keralapsc.gov.in](http://www.keralapsc.gov.in) or photocopied there from. Applications submitted in any other manner will not be considered. The application for rechecking, along with original chalan receipt for the prescribed fee of Rs.75/remitted under the head of account "0051 PSC 105 State PSC 99 Examination Fee", addressed to **The District Officer, Kerala Public Service Commission District Office, MALAPPURAM** should reach the office on or before **10.08.2016**. Application for rechecking received after the stipulated time will not be entertained and fee once remitted will not be refunded.

Any candidate can relinquish his/her right for appointment in writing duly attested by a Gazetted Officer of State/Central Government with signature, name, designation and Office Seal. The request for relinquishment received within 15 days from the date of publication of Ranked List will be honoured against the requisitions of vacancies that are pending with the Commission upto the finalisation of Ranked List. After the publication of the Ranked List, the request for relinquishment will be considered only if such request is received on or before the date of receipt of requisition based on which he/she is to be advised.
