## **NOTIFICATION**

The following list contains the names of candidates found suitable on the basis of the result of the Objective Type (OMR Valuation) Test held on 09.05.2013, Physical Measurement and Practical Test held from 23/09/2014 to 26/09/2014 for the post of Police Constable Driver ( Armed Police Battalion ) on Rs. 10480 – 18300 /- Direct recruitment (Category No. 267/2011) in KAP IV<sup>th</sup> Battalion (Kannur, Wayanad and Kasaragod Revenue Districts) (Kannur, Wayanad and Kasaragod Police Districts) in Police department arranged in the order of merit. The Ranked list is brought into force with effect from 17/11/2014.

The ranked list published by the commission shall remain in force for a minimum period of one year and a maximum period of three years provided that the said list will not continue to be in force if a new list after the expiry of the minimum period of one year is published. Candidates will be advised for appointment in accordance with the rules and orders regarding reservation and rotation as amended from time to time, if applicable, against vacancies reported to the Commission during the pendency of this list. As the advice for appointment depends on the occurrence of vacancies, there is no guarantee that all the candidates included in this list will secure appointment. The candidates remaining in the list at the time of cancellation will have no claim at all for appointment on the basis of inclusion of their names in the list.

According to the existing procedure, revaluation of answer script is not allowed. But the answer scripts will be rechecked, if the candidates apply for the same along with a chalan receipt for the prescribed fee of R50/- (Rupees fifty only) remitted in any one of the Treasuries in the State under the Head of Account "0051-PSC-105 State PSC-99 Examination Fee".

Applications for rechecking of answer scripts should be submitted in the prescribed form available free of cost from the Enquiry sections of the various offices of the Commission or its photocopy or downloaded and printed in A4 size paper from the Commission's website <a href="https://www.keralapsc.gov.in">www.keralapsc.gov.in</a> or photocopied there from. Applications submitted in any other manner will not be considered. Applications for rechecking of invalidated answer script will not be entertained.

Candidates who require photocopy of their OMR Answer Sheets shall remit a fee of Rs. 200/- by way of chalan in any one of the Treasuries in the state under the Head of account ""0051-PSC-800-State PSC-99-Other receipts". The duly filled in application in the prescribed form (available from the Commission's Website <a href="https://www.keralapsc.gov.in">www.keralapsc.gov.in</a>) along with original chalan should be submitted to the District Officer, KPSC District Office, Kasaragod within 45 days from the date of publication of Ranked List. Copy of the Answer sheet will be issued only once to a candidate. Candidates are prohibited from applying for copy of Answer sheet not of their own, and legal proceedings will be initiated against those who violate this condition.

Valid applications for re-checking/ obtaining photocopy of the answer script addressed to **The District Officer**, **KPSC District Office**, "**Tiger Hills**", **Municipal Office Road**, **Pulikkunnu**, **Kasaragod** – **671121** shall reach this office within 45 days from the date on which the Ranked List has come into force. The last date for receipt of applications for rechecking of the answer script/ obtaining photocopy of answer scripts is **31.12.2014**. Applications received after the prescribed time limit and not in the prescribed form will not be entertained. The fee once remitted will not be refunded on any account.

Any candidate can relinquish his/her right for appointment in writing duly attested by a Gazetted Officer of State/Central Govt. with signature, name, designation and Office seal. The request for relinquishment received within 15 days from the date of publication of Ranked List will be honoured against the requisitions of vacancies that are pending with the Commission upto the finalisation of Ranked List. After the publication of the Ranked List, the request for relinquishment will be considered only if such request is received on or before the date of receipt of requisition, based on which he/she is to be advised.

Entries in Column 8 (Community) are based on the communities specified by the candidates in their application forms and proved by them with necessary documents. In the absence of timely information regarding discrepancies if any, the candidates will be advised as incorporated in the list.
