The following is the list of candidates found suitable by the Commission on the basis of the Objective Type (OMR) Tests held on 14-01-2012, 28-01-2012, 25-02-2012 & 21-04-2012 for selection to the post of Last Grade Servants in Various Govt. Owned Companies/Corporations/Boards on Rs. Prescribed for the Post by the Concerned Company/Corporation/Boards in Various Govt. Owned Companies/Corporations/Boards (Category No422/2009) notified in the Gazette dated 30.11.2009, arranged in the order of merit. The Ranked List is brought into force with effect from 16-06-2014.

The List will be in force for a minimum period of one year provided that the said list will continue to be in force till the publication of a new Ranked List after the expiry of a minimum period of one year or till the expiry of three years whichever is earlier. Candidates from this list will be advised for appointment in accordance with the rules and orders regarding reservation and rotation as amended from time to time, if applicable, against vacancies reported to the Commission during the pendancy of this list. As the advice for appointment depends on the occurrence of vacancies, there is no guarantee that all the candidates included in this list will secure appointment. The candidates remaining in this list at the time of cancellation will have no claim at all for appointment on the basis of the inclusion of their names in the list.

According to the existing procedure, revaluation of answer script is not allowed. But the answer scripts will be rechecked if the candidates apply for it in the prescribed application form along with original Chalan receipt for the prescribed fee of Rs.50/-(Rupees Fifty only) remitted in any one of the Treasuries in the State under the Head of Account '0051-PSC -105 State PSC-99 Examination Fee' addressed to the Regional Officer, KPSC Regional Office, Kozhikode. Applications for rechecking of answer scripts should be submitted in the prescribed form available free of cost from the Enquiry Sections of the various Offices of the Commission or its photocopy or down loaded and printed in A4 size paper from the Commission's website www.keralapsc.gov.in or photocopied there from. Applications submitted in any other manner will not be considered. Applications for rechecking received from candidates whose answer scripts have been invalidated will not be considered. The fee once remitted will not be refunded.

In the case of candidates who send applications for rechecking in the prescribed form within the prescribed time limit enclosing Original Chalan receipt as stated above, the marks awarded will be rechecked and the result of the rechecking will be intimated to the candidates from this office. The candidates, who require the Photo copy of their OMR Answer Script (Part A and B) relating to this selection shall remit a fee of **Rs. 200/-(Rupees two hundred only)** by way of Chalan in any of the Treasuries in the State under the Head of Account "0051-PSC-800 Other Receipts-99 Other Receipts". The duly filled up application in the prescribed form (available from the Commission's Website) along with the Original Chalan Receipt should be submitted to the Regional Officer, KPSC Regional Office, Kozhikode. The fee once remitted will not be refunded. A copy of the answer sheet will be issued only once to a candidate. Candidates are permitted to apply for Photocopy of their own Answer Script only.

Valid applications for Rechecking/obtaining photocopy of answer script addressed to **the Regional Officer, K.P.S.C. Regional Office, Kozhikode** shall reach this office within **45 days** from the date on which the Ranked List has come into force (ie. the date on which the Ranked List has been approved by the Commission). The last date for receipt applications for rechecking / obtaining photocopy of the answer script is **30-07-2014.** Applications for rechecking/obtaining photocopy, received after the prescribed time limit and not in the prescribed form will not be entertained.

Entries put in Column 8 (community) are based on the communities specified by the candidates in their applications and proved with necessary documents. The candidates whose communities have not been correctly noted in the list as proved by them in their applications should intimate the fact to the Regional Officer, KPSC Regional Office, Kozhikode within one month from the date of publication of the list, to get the benefit of reservation to which they are entitled to. In the absence of timely information regarding discrepancies, if any, the candidates will be advised on the basis of communities specified in the list.
