The following list contains the names of candidates found suitable on the basis of the result of the Objective Type (OMR Valuation) Test held on **05.03.2011** and the Physical Efficiency Test held from **29.10.2013 to 01.11.2013** for the post of *WOMEN POLICE CONSTABLE (APB)* on ₹. **5930-9590 (PR)** Direct Recruitment (Category No. **171/2010)** in *KAP IV BATTALION (KASARAGOD) POLICE DEPARTMENT IN KASARAGOD DISTRICT* arranged in the order of merit. The Ranked List is brought into force with effect from 04.03.2014.

The Ranked list will be in force till the publication of a new ranked list after the expiry of a minimum period of one year or till the expiry of three years whichever is earlier. Candidates will be advised for appointment in accordance with the rules and orders regarding reservation and rotation as amended from time to time, if applicable, against vacancies reported to the Commission during the pendency of this list. As the advice for appointment depends on the occurrence of vacancies, there is no guarantee that all the candidates included in this list will secure appointment. The candidates remaining in the list at the time of cancellation will have no claim at all for appointment on the basis of inclusion of their names in the list.

According to the existing procedure, revaluation of answer script is not allowed. But the answer scripts will be rechecked, if the candidates apply for the same along with a chalan receipt for the prescribed fee of ₹50/- (Rupees fifty only) remitted in any one of the Treasuries in the State under the Head of Account "0051-PSC-105 State PSC-99 Examination Fee".

Applications for rechecking of answer scripts should be submitted in the prescribed form available free of cost from the Enquiry sections of the various offices of the Commission or its photocopy or downloaded and printed in A4 size paper from the Commission's website <a href="www.keralapsc.gov.in">www.keralapsc.gov.in</a> or photocopied therefrom. Applications

submitted in any other manner will not be considered. Applications for rechecking of invalidated answer script will not be entertained.

Candidates who require photocopy of their OMR Answer Sheets shall remit a fee of ₹200/- by way of chalan in any one of the Treasuries in the state under the Head of account ""0051-PSC-800-State PSC-99-Other receipts". The duly filled in application in the prescribed form (available from the Commission's Website www.keralapsc.gov.in) along with original chalan should be submitted to the District Officer, KPSC District Office, Kasaragod within 45 days from the date of publication of Ranked List. Copy of the Answer sheet will be issued only once to a candidate. Candidates are prohibited from applying for copy of Answer sheet not of their own, and legal proceedings will be initiated against those who violate this condition.

Valid applications for re-checking/ obtaining photocopy of the answer script addressed to **The District Officer, KPSC District Office, "Tiger Hills", Municipal Office Road, Pulikkunnu, Kasaragod** – **671121** shall reach this office within 45 days from the date on which the Ranked List has come into force. The last date for receipt of applications for rechecking of the answer script/ obtaining photocopy of answer scripts is **19.04.2014.** Applications received after the prescribed time limit and not in the prescribed form will not be entertained. The fee once remitted will not be refunded on any account.

Any candidate can relinquish his/her right for appointment in writing duly attested by a Gazetted Officer of State/Central Govt. with signature, name, designation and Office seal. The request for relinquishment received within 15 days from the date of publication of Ranked List will be honoured against the requisitions of vacancies that are pending with the Commission upto the finalisation of Ranked List. After the publication of the Ranked List, the request for relinquishment will be considred only if such request is received on or before the date of receipt of requisition, based on which he/she is to be advised.

Entries in Column 8 (Community) are based on the communities specified by the candidates in their application forms and proved by them with necessary documents. The candidates whose communities have not been correctly noted in the list as proved by them in their application should intimate the fact to the District Officer, KPSC District Office, "Tiger Hills", Pulikkunnu, Municipal Office Road, Kasaragod 671121 within one month from the date of publication of this list to get the benefit of reservation to which they are entitled to. In the absence of timely information regarding discrepancies if any, the candidates will be advised as incorporated in the list.
