Note – 7:- Copy of answer scripts of the OMR Test held on **03.12.2011** will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List. Candidates whose Register Numbers are invalidated are advised to refer to Notification No. ER II(3) 1323/12/EW dtd. 6.9.2013 and 27.9.2013.

Candidates who wish to obtain photocopy of their OMR answer sheet (Part A & Part B) relating to this selection shall remit the fee of Rs.200 in any of the Treasuries in the State (Head of account 0051-PSC-800-Other Receipts-99-Other Receipts). The duly filled in application in the prescribed form (available from the Commission's website www.keralapsc.gov.in along with the original chalan should be submitted to the District Officer, Kerala Public Service Commission, Ernakulam within 45 days from the date of publication of the Ranked List. A copy of an answer sheet will be issued only once to candidate. Copies of OMR answer sheets invalidated to any defect will not be issued. Candidates are prohibited from applying for a copy of an answer sheet which is not their own, and legal proceedings will be initiated against those who do so.

Re-checking of answer scripts will not be allowed before publishing the Ranked List.
