Note :- (5) Candidates belonging to Other Backward Classes included in this list who are required to produce Non – Creamy Layer Certificate as per G.O (P) No: 81/09/SC/ST/DD dated 26.09.2009 shall produce the same along with the other documents mentioned above at the time of verification of original documents. SC/ST candidates shall produce Community Certificate obtained from Revenue Authorities not below the Rank of Tahsildar. Candidates in the Main List who fail to produce the required NCLC/Caste Certificate will not be entitled to the benefit of Community reservation and will be considered as open competition candidates.

Note :- (6) Copy of answer scripts of the OMR Test held on **20/02/2015** will be issued to those candidates who, apply for the same remitting the prescribed fee after publication of the Ranked List.
