### **NOTIFICATION**

The following List contains the names of candidates found suitable and arranged on merit on the basis of the result of the Objective Type (OMR) Test held on **13.06.2012** for the Post of **Draftsman Gr II(State wide)** on **Rs.6690-11070** in **Kerala Water Authority**. This Ranked List is brought into force with effect from 30.03.2015.

The List will be in force for a minimum period of one year provided that the said list will continue to be in force till the publication of a new Ranked List after the expiry of a minimum period of one year or till the expiry of three years whichever is earlier. Candidates from this list will be advised for appointment in accordance with the rules and orders regarding reservation and rotation as amended from time to time, if applicable, against vacancies reported to the Commission during the pendency of the list. As the advice for appointment depends on the occurrence of vacancies there is no guarantee that all the candidates included in the list will secure appointment. The candidates remaining in the list at the time of cancellation will have no claim at all for appointment on the basis of the inclusion of their names in the list.

According to the existing procedure, revaluation of answer script is not allowed. But answer script will be rechecked if the candidates apply for it along with a chalan receipt for the prescribed fee of Rs.50/- (rupees Fifty only) remitted in any one of the Treasuries in the State under the Head of Account, **"0051-PSC-105 State PSC 99 Examination fee"**, addressed to the **DEPUTY SECRETARY (EXAMINATIONS)-II, KERALA PUBLIC SERVICE COMMISSION, PATTOM.P.O, THIRUVANANTHAPURAM -695 004** should reach the office within 45 days from the date on which the Ranked List has come into force.

Applications for rechecking of answer scripts should be submitted in the prescribed form available free of cost from the Enquiry sections of the various offices of the Commission or its photocopy or downloaded form and printed in A4 size paper from the Commission's website: [www.keralapsc.gov.in](http://www.keralapsc.gov.in) or photocopied there from. Applications submitted in any other manner will not be considered.

In the case of candidates who send applications for rechecking in the prescribed form within the prescribed time limit enclosing original chalan receipt as stated above, the marks awarded will be rechecked and the result of the rechecking will be intimated to the candidates from this office.

Candidates who wish to obtain a photocopy of their OMR answer sheet (Part A and B) relating to this selection shall remit a fee of Rs.200/- (Rupees Two hundred only) by way of chalan in any of the Treasuries in the State (head of account, "0051-PSC-800 State PSC-99 other receipts"). The duly filled up application in the prescribed form (available from the

Commission's website) along with the original chalan should be submitted to the **DEPUTY SECRETARY (EXAMINATIONS)-II, KERALA PUBLIC SERVICE COMMISSION, PATTOM, THIRUVANANTHAPURAM** within 45 days from the date on which the Ranked List has come into force. A copy of the answer sheet will be issued only once to a candidate. Candidates are prohibited from applying for a copy of answer sheet which is not their own, and legal proceedings will be initiated against those who do so.

The last date for the receipt of applications for rechecking/obtaining photocopy of the answer script is **14.05.2015**. Applications for rechecking/obtaining photocopy, received after the prescribed time limit and not in the prescribed form will not be entertained.

Entries in column 8 are based on the Communities specified by the candidate in their application forms and proved by them with necessary documents. The candidate whose communities have not been correctly noted in this list as proved by them in their application should intimate the fact to the Deputy Secretary (Examinations)-II, Kerala Public Service Commission, Thiruvananthapuram- 695 004 within one month from the date of publication of this list to get the benefit of reservation to which they are entitled to. In the absence of timely information regarding discrepancies if any, the candidate will be advised as incorporated in the list.

"Any candidate can relinquish his/her right for appointment in writing duly attested by a Gazetted Officer of State/Central Government with signature, name, designation and Office Seal. The request for relinquishment received within 15 days from the date of publication of Ranked List will be honoured against the requisitions of vacancies that are pending with the Commission upto the finalisation of Ranked List. After the publication of the Ranked List, the request for relinquishment will be considered only if such request is received on or before the date of receipt of requisition based on which he/she is to be advised".
