**NOTE (1) :-** According to the existing procedure, revaluation of Answer Script is not allowed. But Answer Scripts will be rechecked if the candidates apply for in the prescribed application form available free of cost from the Enquiry Sections of the various Officers of the Commission or its photocopy, or downloaded and printed in A4 size paper from the Commission's website <u>www.keralapsc.gov.in</u> or Photocopied there from along with prescribed fee of **Rs. 75/-** (**Rupees Seventy Five Only**) under the Head of Account "0051 - PSC - 105 State PSC 99 - Examination Fee" addressed to the Deputy Scretary (Examinations)-I, Kerala Public Service Commission, Pattom P.O., Thiruvananthapuram. - 4

Applications submitted in any other manner will not be considered. A period of 45 (Forty Five) days time to apply for rechecking of Answer Scripts will be allowed to candidates with effect from the Date of Approval of the Ranked List (on or before 11.04.2016). The candidates can avail only one chance after the Approval of Ranked List. Application for Rechecking received after the stipulated time will not be entertained and Fee once remitted will not be refunded.

**NOTE (2):-** Candidates who wish to obtain a photocopy of their OMR Answer Sheets (Part A & Part B) relating to this selection shall remit a Fee of **Rs. 300/- (Rupees Three Hundred only)** in any of the Treasuries in the State (Head of Account : **0051 - PSC - 800 - State PSC -99-Other Receipts).** The duly filled in application in the prescribed form (available from the Commission's website **www.keralapsc.gov.in** along with the original chalan should be submitted to the **Deputy Scretary (Examinations)-I, Kerala Public Service Commission, Pattom P.O., Thiruvananthapuram. - 4** within 45 (Fourty Five) days from the date of approval of the Ranked List (on or before 11.04.2016)

A copy of an answer sheet will be issued only once to a candidate. Copies of OMR Answer Sheets invalidated due to any defect will not be issued. Candidates are prohibited from applying for copy of an answer sheet which is not their own, and legal proceedings will be initiated against those who do so.

**NOTE (3):-** Any candidate can relinquish his/her right for appointment in writing duly attested by a Gazetted Officer of Stat/ Central Government with Signature, Name, Designation and Office Seal. The request for relinquishment received within 15 days from the date of publication of Ranked List will be honoured against the requisitions of vacancies that are pending with the Commission up to the finalization of the Ranked List. After the publication of the Ranked List, the request for relinquishment will be considered only if such request is received on or before the date of receipt of requisition, based on which he/she is to be advised.
