**NOTIFICATION**

The following is the Ranked List of candidates for selection to the post of **MALE WARDER (NCA – HINDU NADAR)** (Category No. 394/2011) on **₹.10480 - 18300/-** in **JAIL DEPARTMENT** in Kannur Unit found suitable by the Commission on the basis of OMR test held on 29.12.2012, Verification of original documents, Physical Measurement and Physical Efficiency Test of candidates included in the Short List published on 17.09.2014 and arranged in the order of merit. This Ranked List is brought into force w.e.f. 20.01.2015 and will be valid until candidates are advised and appointed against the vacancies that arise due to the paucity of candidates belonging to Hindu Nadar Community during the currency of the Ranked List published on 28.07.2010 (Category No. 235/2008) for the above post.

According to the existing procedure, revaluation of answer script is not allowed. But the answer scripts will be rechecked if the candidates apply for along with a Chalan receipt for the prescribed fee of ₹.50/- (Rupees Fifty only) in the prescribed application form remitted in any one of the Treasuries in the State under the Head of Account **“0051-PSC-105 State PSC-99 Examination Fee”** addressed to the District Officer, KPSC District Office, Kannur. Candidates can also apply for a photocopy of their answer script. The application should be in the prescribed form (available on the Commission’s website) along with a chalan receipt for the prescribed fee of ₹. 200/- (Rupees two hundred only) remitted in any one of the Treasuries in the State under the Head of Account **“0051-PSC-800 Other Receipts-99 Other Receipts”** addressed to the **District Officer, KPSC District Office, Kannur.**

In the case of candidates who send applications for rechecking in the prescribed form within the prescribed time limit enclosing Original Chalan receipt as stated above, the marks awarded will be rechecked and the result of the rechecking will be intimated to the candidates from this office.

Applications for Rechecking and for photocopy should reach the office within **45 days** from the date on which the Ranked List has come into force. Applications received after the stipulated time will not be entertained and fee once remitted will not be refunded. Copy of the answer scripts of a test will be issued only once to a candidate. Candidates are informed that they are prohibited from applying for a copy of answer script which is not their own, and legal proceedings will be initiated against such person.

Applications for rechecking of answer script should be submitted in the prescribed form available free of cost from the Enquiry Sections of the various Offices of the Commission or its photocopy, application form downloaded and printed in A4 size paper from the Commission's website [www.keralapsc.gov.in](http://www.keralapsc.gov.in). Applications submitted in any other manner will not be considered. The last date for receipt of application for rechecking and for photocopy of the answer script is **06.03.2015**.

The result of re checking/copy of answer script of the candidates who apply as per rules will be intimated/forwarded from this office.

Entries put in Column 10 (community) are based on the communities specified by the candidates in their application forms and proved by them with necessary documents. The candidates whose communities have not been correctly noted in the list as proved by them in their applications should intimate the fact to the District Officer, KPSC District Office, Kannur within one month from the date of publication of the list, to get the benefit of reservation to which they are entitled to. In the absence of timely information regarding discrepancies, if any, the candidates will be advised as incorporated in the list.

“Any candidate can relinquish his/her right for appointment in writing duly attested by a Gazetted Officer of State/Central Government with signature, name, designation and Office Seal. The request for relinquishment received within 15 days from the date of publication of Ranked List will be honoured against the requisition of vacancies that are pending with the Commission up to the finalisation of Ranked List. After the publication of the Ranked List, the request for relinquishment will be considered only if such request is received on or before the date of receipt of requisition, based on which he/she is to be advised”.
