Copies of OMR answer sheets invalidated due to any defect will not be issued. Candidates are prohibited from applying for a copy of an answer sheet which is not their own, and legal proceedings will be initiated against those who do so.

**NOTE II:** A period of 45 days time to apply for rechecking of Answer Scripts will be allowed to candidates with effect from the date of approval of the Ranked List. The candidates can avail only one chance after the approval of Ranked List.

Candidates desiring to get their answer script rechecked to the written test held for selection to the post may apply for rechecking within 45 days from the date of approval of the Ranked List. (On or before **27.06.2013**)

"Applications for rechecking of answer scripts should be submitted in the prescribed form available free of cost from the Enquiry sections of the various offices of the Commission or its photocopy, or downloaded and printed in A4 size paper from the Commission's Website **www.keralapsc.gov.in** or photocopied there from.
