NOTE I :

Candidates who wish to obtain a photocopy of their OMR answer sheet (Part A and B) relating to this selection shall remit a fee of Rs.300/- in any of the Treasuries in the State (**head of account, "0051-PSC-800-State PSC-99 other**

receipts”). The duly filled in application in the prescribed form (available from the Commission’s website) along with the original chalan should be submitted to the **DEPUTY SECRETARY (EXAMINATIONS)-I, KERALA PUBLIC SERVICE COMMISSION, PATTOM, THIRUVANANTHAPURAM -4** within 45 days from the date on which this Ranked List has brought into force. A copy of the answer sheet will be issued only once to a candidate. Copy of OMR sheet invalidated due to any defect will not be issued. Candidates are prohibited from applying for a copy of answer sheet which is not their own, and legal proceedings will be initiated against those who do so. The last date for the receipt of application is 03.03.2016. Applications received after the prescribed date will not be entertained.

NOTE II :

A period of 45 days time to apply for rechecking of Answer Scripts will be allowed to candidates with effect from the date on which this Ranked List is brought into force. The candidates can avail only one chance.

“Application for rechecking of answer scripts should be submitted in the prescribed form available free of cost from the Enquiry sections of the various offices of the Commission or it’s photocopy or down loaded form and printed in A4 size paper from the Commission’s website:www.keralapsc.org or photocopies there from. Applications submitted in any other manner will not be considered. ”

NOTE III :

“Any candidate can relinquish his/her right for appointment in writing duly attested by a Gazetted Officer of State/Central Government with signature, name, designation and Office Seal. The request for relinquishment received within 15 days from the date of publication of Ranked List will be honoured against the requisitions of vacancies that are pending with the Commission up to the finalisation of Ranked List. After the publication of the Ranked List, the request for relinquishment will be considered only if such request is received on or before the date of receipt of requisition based on which he/she is to be advised”.
