Note I :The result of the register numbers 200134,200135,200136 is withheld and that will be released subject to the final judgement of the Hon' High Court in W.P(c)No.30575/2010(V) dated 05.10.2010. The result of the register numbers 200118 and 200131 is withheld as these numbers are proposed to be deleted from the Probability List.

The Ranked List will be in force for a minimum period of one year provided that the said list will continue to be in force till the publication of a new Ranked List after the expiry of a minimum period of one year or till the expiry of three years whichever is earlier. Candidates from this list will be advised for appointment in accordance with the rules and orders regarding reservation and rotation as amended from time to time, if applicable, against vacancies reported to the Commission during the pendency of the list. As the advice for appointment depends on the occurrence of vacancies there is no guarantee that all the candidates included in the list will secure appointment. The candidates remaining in the list at the time of cancellation will have no claim at all for appointment on the basis of the inclusion of their names in the list.

NOTE II: Candidates who wish to obtain a photocopy of their OMR answer sheet (Part A & Part B) relating to this selection shall remit the fee of Rs.200/- in any of the Treasuries in the State (Head of account:0051 PSC- 800-State PSC-99- other receipts). The duly filled in application in the prescribed form (available from the Commission's website www.keralapsc.gov.in) along with the original chalan should be submitted to The Deputy Secretary (Examinations-I), Kerala Public Service Commission, Thiruvananthapuram-4 within 45 days from the date of publication of this ranked list (on or before 15.08.2013) Copy of answer sheet will be issued only once to a candidate. Candidates are prohibited from applying for copy of answer sheet which is not their own, and legal proceedings will be initiated against those who do so.

NOTE III : A period of 45 days time to apply for rechecking of Answer Scripts will be allowed to candidates with effect from the date of publication of the Ranked List. The candidates can avail only one chance. Candidates desiring to get their answer script rechecked to the written test held for selection to the post may apply for rechecking within 45 days from the date of publication of the Ranked List. (On or before 15.08.2013) "Applications for rechecking of answer scripts should be submitted in the prescribed form available free of cost from the Enquiry sections of the various offices of the Commission or its photocopy, or downloaded and printed in A4 size paper from the Commission's Website www.keralapsc.gov.in or photocopied there from. Applications submitted in any other manner will not be considered."

The application for rechecking, along with original chalan receipt for the prescribed fee of Rs. 50/- under the head of account "0051 - PSC 105 State PSC 99 – Examination Fee",addressed to The Deputy Secretary (Examinations-I), Kerala Public Service Commission, Thiruvananthapuram-4 should reach the office within 45 days from the date of approval of the Ranked List (on or before 15.08.2013). Applications received after the stipulated time will not be entertained and fee once remitted will not be refunded.
