#### NOTE II:

Candidates who wish to obtain a photocopy of their OMR answer sheet (Part A& Part B) relating to this selection shall remit the fee of Rs.200/- in any of the Treasuries in the State (Head of account: 0051 PSC-105-State PSC-99 other receipts). The duly filled in application in the prescribed form (available from the Commission's website <a href="https://www.keralapsc.gov.in">www.keralapsc.gov.in</a>) along with the original chalan should be submitted to **The Deputy Secretary, Examination Wing, Kerala Public Service Commission, Pattom, Thiruvananthapuram** within 45 days from the date on which this ranked list is brought into force. A copy of an answer sheet will be issued only once to a candidate. Copies of OMR answer sheets invalidated due to any defect will not be issued. Candidates are prohibited from applying for a copy of an answer sheet which is not their own, and legal proceedings will be initiated against those who do so. The last date for receipt of applications is **17.08.2013.** Applications received after the prescribed date will not be entertained.

The application for rechecking, along with original chalan receipt for the prescribed fee of Rs.50/- under the head of account "0051 - PSC 105 State PSC 99 – Examination Fee", addressed to **The Deputy Secretary, Examination Wing, Kerala Public Service Commission, Pattom, Thiruvananthapuram** should reach the office on or before **17.08.2013.** Application for rechecking received after the stipulated time will not be entertained and fee once remitted will not be refunded.
