The following list contains the names of candidates found suitable by the commission on the basis of the result of the Objective Type (OMR) Test held on 25.02.2011 for selection to the post of Peon/Watchman (NCA-ST, Muslim, LC & OX) on Rs. 2900-4655/-(PR) in K.S.F.E arranged in the order of merit. The Ranked List is brought into force with effect from 22.7.2013. The Ranked List will be in force until the candidates are advised and appointed against the vacancies earmarked for ST, Muslim, LC & OX communities but remain unfilled due to the paucity of candidates during the currency of Ranked List published on 31.1.2006 (Category No. 214/2003) for the above post.

According to the existing procedure, revaluation of answer script is not allowed. But rechecking of marks will be done on payment of Rs.50/- (Rupees Fifty only). The fee should be remitted in any one of the Treasuries in the State under the Head of Account "0051 PSC 105 STATE PSC- 99 EXAMINATION FEE". Application for re-checking of answer script should be submitted in the prescribed form downloaded and printed in A4 size paper from the commission's website www.keralapsc.gov.in or photocopies there from . Applications submitted in any other manner will not be considered. The original chalan receipt together with the application for rechecking should reach the Regional Officer, KPSC Regional Office, Civil Station, Kozhikode within 45 days from the date on which this Ranked List is published by the Public Service Commission. The fee once remitted will not be refunded on any account.

Candidates who wish to obtain photocopy of their Answer Sheet (Part A & Part B) relating to this selection shall remit a fee of **Rs.200/-(Rupees Two hundred only)** by way of chalan in any one of the Treasuries in the State (Head of Account "0051-PSC-800 - other receipts -99-Other receipts"). The duly filled up application in the prescribed form (available from the Commission's website) along with the original chalan should be submitted to the **Regional Officer**, **KPSC Regional Office**, **Civil Station**, **Kozhikode**. Copy of the answer sheet will be issued only once to a candidate. Copies of OMR answer sheets invalidated due to any defect will not be issued. Candidates are prohibited from applying for copy of answer sheet which is not their own, and legal proceedings will be initiated against those who do so.

Valid applications for rechecking/obtaining photocopy of Answer Script addressed to **Regional Officer, KPSC Regional Office, Civil Station, Kozhikode** shall reach this office within 45 days from the date on which the Ranked List has come into force (ie, the date on which the ranked List has been approved by the Commission).

The last date for receipt of applications for rechecking/obtaining photocopy of Answer Script is 04.09.2013. Application for rechecking/obtaining photocopy received after the prescribed time limit and not in the prescribed form will not be entertained.
