Applications for rechecking of answer scripts should be submitted in the prescribed form available free of cost from the Enquiry sections of the various offices of the Commission or it's photocopy or application form downloaded and printed in A4 size paper from the Commission's website: <u>www.keralapsc.gov.in</u> or photocopied there from. Applications submitted in any other manner will not be considered.

In the case of candidates who send applications for rechecking in the prescribed form within the prescribed time limit enclosing original chalan receipt as stated above, the marks awarded will be rechecked and the result of the rechecking will be intimated to the candidates from this office.

A copy of the answer sheet will be issued only once to a candidate. Candidates are prohibited from applying for a copy of answer sheet which is not their own, and legal proceedings will be initiated against those who do so.

The last date for the receipt of applications for rechecking/obtaining photocopy of the answer script is **12.09.2013.** Applications for rechecking/obtaining photocopy, received after the prescribed time limit and not in the prescribed form will not be entertained.
