The following list contains the names of candidates found suitable on the basis of the result of the Objective Type (OMR valuation) test held on 18.04.2013 and the verification of original documents of candidates included in the Probability List published on.13.08.14 for the post of **AYAH (Cat. No.286/2011)** on **Rs.8500-13210** in **Various Departments** in **Kozhikode District** for which notification for selection was published in the Gazette dated **29.08.11** arranged in the order of merit. This Ranked List is brought into force with effect from 07-09-2015

The Ranked List will be in force for a minimum period of one year provided that the said list will continue to be in force till the publication of a new Ranked List after the expiry of a minimum period of one year or till the expiry of three years whichever is earlier. Candidates from this list will be advised for appointment in accordance with the rules and orders regarding reservation and rotation as amended from time to time, if applicable, against vacancies reported to the Commission during the pendancy of this list. As the advice for appointment depends on the occurrence of vacancies, there is no guarantee that all the candidates included in this list will secure appointment. The candidates remaining in this list at the time of cancellation will have no claim at all for appointment on the basis of the inclusion of their names in the list.

Any candidates can relinquish his/her right for appointment in writing duly attested by a Gazetted Officer of State/Central Government with signature, name, designation and office seal. The request for relinquishment received within 15 days from the date of publication of Ranked List will be honoured against the requisitions of vacancies that are pending with the Commission up to the finalisation of the Ranked List. After the publication of the Ranked List, the request for relinquishment will be considered only if such request is received on or before the date of the receipt of the requisition, based on which he/she is to be advised.

According to the existing procedure, revaluation of answer script is not allowed. But the answer scripts will be rechecked if the candidates apply for it along with a chalan receipt for the prescribed fee for Rs. 75/-(Rupees SEVENTY FIVE) remitted in any one of the Treasuries in the State under the Head of Account **'0051 PSC 105 State PSC-99 Examination Fee'.** The application for rechecking with the original chalan receipt should reach the <u>District Officer, KPSC District Office, Civil Station,</u> <u>Kozhikode -20 on or</u> before 21.10.2015 **ie., within 45 days** from the date on which the rank list is brought into force. Application for re-checking received after the prescribed time limit will not be entertained. The Fee once remitted will not be refunded. Applications for rechecking of answer scripts should be submitted in the prescribed form available free of cost from the Enquiry Sections of the various Offices of the Commission or its photocopy or down loaded and printed in A 4 size paper from the Commission's website <u>www.keralapsc.org</u> or photocopied there from. Applications submitted in any other manner will not be considered. Applications for re-checking received from candidates whose answer scripts have been invalidated will not be considered.

Candidates who wish to obtain photocopies of their OMR answer script (Part A & Part B) relating to this selection should remit the prescribed fee of Rs. 300/-(Rupees Three Hundred only)in any of the Treasuries in the State under the Head of Account "0051-PSC-800-Other Receipts-99-other receipts". The duly filled in application in the prescribed form available from the Commission's website www.keralapsc.org along with the original chalan should be submitted to the District Officer, Kerala Public Service Commission District Office, Civil Station, Kozhikode – 20 on or before 21.10.2015 ie., within 45 days from the date on which the Ranked list is brought into force. The application received after the prescribed time limit will not be entertained. The Fee once remitted will not be refunded. A copy of an answer sheet will be issued only once to a candidate. Copies of OMR answer sheets invalidated due to any defect will not be issued. Candidates are prohibited from applying for a copy of an answer sheet which is not their own and legal proceedings will be initiated against those who do so.

Entries put in Column 4 (community) are based on the communities specified by the candidates in their applications and proved with necessary documents. The candidates whose communities have not been correctly noted in the list as proved by them in their applications should intimate the fact to the District Officer, KPSC District Office, Kozhikode within one month from the date of publication of the list, to get the benefit of reservation to which they are entitled to. In the absence of timely information regarding discrepancies, if any, the candidates will be advised on the basis of communities specified in the list.

The candidate who have obtained 61 marks and above in the Objective Type (OMR valuation) test held on 18.04.13 have been included in the Main List of the Ranked List.
