NOTIFICATION

The following list contains the names of candidates found suitable on the basis of the result of the Objective Type (OMR Valuation) Test held on 03-10-2012 and the verification of original documents of candidates included in the probability list published on 17-01-13 and Addendum Notification published on 05-03-14 for the post of Village Extension Officer Gr.II (Special Recruitment for Physically disabled persons belonging to partially Blind, Partially Deaf and Orthopaedically Handicapped (Both Upper & Lower Extremities – Minor diffects) categories only. on Rs. 9940-16580 in Rural Development Departments in Kozhikode District for which notification for selection was published in the Gazette dated 30-04-12 arranged in the order of merit. This Ranked List is brought into force with effect from 15-07-2014.

The Ranked List prepared is intended to make recruitment to the backlog vacancies of PH candidates during the period from 01-01-2004 to 31-12-2007 as earmarked for the various categories and PH groups as per GO(P) No. 7/2011/SWD dated 24-1-2011 and will remain in force for a maximum period of three years subject to the condition that the Ranked List will cease to exist as and when candidates are advised and appointed against the above mentioned backlog vacancies. As the advice for appointment depends on the occurrence of vacancies, there is no guarantee that all the candidates included in this list will secure appointment. The candidates remaining in this list at the time of cancellation will have no claim at all for appointment on the basis of the inclusion of their names in the list.

According to the existing procedure, revaluation of answer script is not allowed. But the answer scripts will be rechecked if the candidates apply for it along with a chalan receipt for the prescribed fee of Rs. 50/- (Rupees Fifty only) remitted in any one of the Treasuries in the State under the Head of Account **“0051 PSC 105 STATE PSC- 99 EXAMINATION FEE”**. The application for re-checking with the original chalan receipt should reach the **District Officer, KPSC District Office, Civil Station, Kozhikode – 20**

within 45 days from the date on which this Notification is officially released by the Public Service Commission ie, on or before 28-08-2014. Application for re-checking received after the prescribed time limit will not be entertained. The fee once remitted will not be refunded.

Applications for re-checking of answer scripts should be submitted in the prescribed form available free of cost from the Enquiry Sections of the various offices of the Commission or its photocopy or downloaded and printed in A4 size paper from the Commission's website www.keralapsc.gov.in or photocopied there from. Applications submitted in any other manner will not be considered. Applications for re-checking received from candidates whose answer scripts have been invalidated will not be considered.

Candidates who wish to obtain photocopies of their OMR answer script (Part A & Part B) relating to this selection should remit the prescribed fee of **Rs.200/-(Rupees Two hundred only)** in any of the Treasuries in the State under the **Head of Account: "0051-PSC-800 Other Receipts-99-other receipts"**. The duly filled in application in the prescribed form (available from the Commission's website www.keralapsc.gov.in) along with the original chalan should be submitted to **the District Officer, Kerala Public Service Commission District Office, Civil Station, Kozhikode- 20** within 45 days on the date of publication of this Ranked List ie, on or before 28-08-2014. The application received after the prescribed time limit will not be entertained. The Fee once remitted will not be refunded. A copy of an answer sheet will be issued only once to a candidate. Copies of OMR answer sheets invalidated due to any defect will not be issued. Candidates are prohibited from applying for a copy of an answer sheet which is not their own, and legal proceedings will be initiated against those who do so.

The candidates who have obtained 68 (**Marks for OMR test + Grace Marks for disability**) marks are included in the Partially Blind category, candidates who secured 55 (marks for the OMR test + Grace marks for disability) marks and above are included in partially Deaf category and 73 (marks for the OMR test + Grace marks for disability) marks and above are included in the orthopaedically handicapped category of this Ranked list.

Any candidate can relinquish his/her right for appointment in writing duly attested by a Gazetted Officer of State/Central Government with signature, name, designation and

office seal. The request for relinquishment received within 15 days from the date of publication of Ranked list will be honoured against the requisitions of vacancies that are pending with the commission up to the finalization of Ranked list. After publication of the Ranked List the request for relinquishment will be considered only if such request is received on or before the date of receipt of requisition, based on which he/she is to be advised.

When a candidate whose name has been included in more than one Ranked list for the same post in the same department/different departments finalized on the basis of the very same or any other notification under different methods of recruitment/appointment and for which common advice list is prepared and the said Ranked list are operated simultaneously, and when such a candidate is advised by the commission from any one of the aforesaid Ranked lists, his name shall be abrogated from the other Ranked lists.
