The last date for receipt of applications is **21.11.2014.** Applications received after the prescribed date will not be entertained.

NOTE II:

A period of 45 days time to apply for rechecking of Answer Scripts will be allowed to candidates with effect from the date on which this Ranked List is brought into force. The candidates can avail only one chance.
