The Ranked List will be in force for a minimum period of one year provided that the said list will continue to be in force till the publication of a new Ranked List after the expiry of a minimum period of one year or till the expiry of three years whichever is earlier. Candidates from this list will be advised for appointment in accordance with the rules and orders regarding reservation and rotation as amended from time to time, if applicable, against vacancies reported to the Commission during the pendency of the list. As the advice for appointment depends on the occurrence of vacancies there is no guarantee that all the candidates included in the list will secure appointment. The candidates remaining in the list at the time of cancellation will have no claim at all for appointment on the basis of the inclusion of their names in the list.

According to the existing procedure, revaluation of answer script is not allowed. But answer script will be rechecked if the candidates apply for in the prescribed application form along with a chalan receipt for the prescribed fee of Rs.50/- (rupees Fifty only) remitted in any one of the Treasuries in the State under the Head of Account, **“0051-PSC-105 State PSC 99 Examination fee”**, addressed to the **DEPUTY SECRETARY (EXAMINATIONS)-II, KERALA PUBLIC SERVICE COMMISSION, PATTOM.P.O, THIRUVANANTHAPURAM -695 004 .**

Candidates can also apply for a photocopy of their answer script. The application should be in the prescribed form (available on the commission's website) along with a chalan receipt for the prescribed fee of Rs. 200/- (Rupees Two hundred only) remitted in any one of the treasuries in the State under the head of account " 0051-PSC- 800 other receipts-99 other receipts" addressed to the DEPUTY SECRETARY (EXAMINATIONS)- II, in the above said address.

Applications for rechecking and for photocopy should reach the office within 45 days from the date on which the Ranked List has come into force. Applications received after the stipulated time will not be entertained and fee once remitted will not be refunded. Copy of the answer scripts of a test will be issued only once to a candidate. Copies of OMR answer scripts invalidated by the commission will not be issued. Candidates are informed that they are prohibited from applying for a copy of answer script which is not their own, and legal proceedings will be initiated against such persons.

Applications for rechecking of answer scripts should be submitted in the prescribed form available free of cost from the Enquiry sections of the various offices of the Commission or its photocopy or down loaded form and printed in A4 size paper from the Commission's website: www.keralapsc.gov.in or photocopied there from. Applications submitted in any other manner will not be considered. Applications for re-checking received from candidates whose answer scripts have been invalidated will not be considered. **The last date for receipt of application for rechecking and for photocopy of the answer script is 24.12.2014.**

The result of rechecking copy of answer script of the candidates who apply as per rules will be intimated/forwarded from this office.

Entries put in column 8 are based on the Communities specified by the candidate in their application forms and proved by them with necessary documents. The candidate whose communities have not been correctly noted in this list as proved by them in their application should intimate the fact to the Deputy Secretary (Examinations)-II, Kerala Public Service Commission, Thiruvananthapuram- 695 004 within one month from the date of publication of this list to get the benefit of reservation to which they are entitled to. In the absence of timely information regarding discrepancies if any, the candidate will be advised as incorporated in the list.

Note:- Any candidate can relinquish his/her right for appointment in the writing duly attested by a Gazetted Officer of State/Central Government with signature, name, designation and office seal. The request for relinquishment receive within 15 days from the date of publication of Ranked List will be honoured against the requisitions of vacancies that are pending with the Commission upto the finalisation of the Ranked List. After the publication of the Ranked List, the request for relinquishment will be considered only if such request is received on or before the date of receipt of requisition, based on which he/she is to be advised.
