The copy of an answer sheet will be issued only once to a candidate. Copies of OMR answer sheets invalidated due to any defect will not be issued. Candidates are prohibited from applying for the copy of an answer sheet which is not their own, and legal proceedings will be initiated against those who do so.
- **NOTE (2):** A period of forty five days time to apply for rechecking of Answer Scripts will be allowed to candidates with effect from the date of approval of Ranked List. The candidates can avail only one chance after the approval of Ranked List. Application for rechecking received after the stipulated time will not be entertained and fee once remitted will not be refunded.

The request for relinquishment received within 15 days from the date of publication of Ranked List will be honoured against the requisitions of vacancies that are pending with the Commission up to the finalization of the Ranked List.
