The duly filled in application in the prescribed form (available from the Commission's website <a href="www.keralapsc.gov.in">www.keralapsc.gov.in</a>) along with the original chalan receipt should be submitted to **The Deputy Secretary (Examination)**, **Kerala Public Service Commission, Pattom, Thiruvananthapuram** within 45 days from the date on which this ranked list is brought into force. A copy of an answer sheet will be issued only once to a candidate. Candidates are prohibited from applying for a copy of an answer sheet which is not their own, and legal proceedings will be initiated against those who do so. The last date for receipt of applications is **30.01.2015**. Applications received after the prescribed date will not be entertained.

## **NOTE II:**
