Applications for rechecking and for photocopy should reach the office within 45 days from the date on which the Ranked List has came into force. Applications received after the stipulated time will not be entertained and fee once remitted will not be refunded. Copy of the answer scripts of a test will be issued only once to a candidate.; Copied of OMR answer scripts invalidated by the commission will not be issued. Candidates are informed that they are prohibited from applying for a copy of answer script which is not their own, and legal proceedings will be initiated against such persons.

The result of rechecking copy of answer script of the candidated who apply as per rules will be intimated/forwarded from this office.

Entries put in column 8 are based on the Communities specified by the candidate in their application forms and proved by them with necessary documents. The candidate whose communities have not been correctly noted in this list as proved by them in their application should intimate the fact to the Deputy Secretary (Examinations)-II, Kerala Public Service Commission, Thiruvananthapuram- 695 004 within one month from the date of publication of this list to get the benefit of reservation to which they are entitled to. In the absence of timely information regarding discrepancies if any, the candidate will be advised as incorporated in the list.
