Such candidates in the main list who fail to produce the required Non-Creamy Layer Certificate will not be entitled to the benefit of Community reservation and will be considered as Open Competition candidates. As regard to such candidates in the Supplementary Lists of Other Backward Classes, their register Numbers will be deleted from the Short List without further notice, if they fail to produce the Non- Creamy Layer Certificate.
5. The place, date and time of interview will be intimated in due course.
6. According to the existing procedure, revaluation of answer scripts is not allowed. But candidates can apply for the rechecking of their answer scripts only after publication of the Ranked List. The details will be published along with the Ranked List.
